

Exempt Subdivision Information

Per Section 9.17.1.1 of the Pinehurst Development Ordinance (PDO), an Exempt Subdivision is a subdivision that involves the: (a) the combination or recombination of portions of previously subdivided and recorded lots where the total number of lots is not increased and the resultant lots are equal to or exceed the standards of the PDO; (b) the division of land into parcels greater than ten (10) acres where no street right-of- way dedication is involved; (c) the public acquisition of purchase of strips of land for the widening or opening of streets; (d) the division of a tract in single ownership whose entire area is no greater than two (2) acres into not more than three (3) lots, where no street right-of-way dedication is involved and where the resultant lots are equal to or exceed the standards of the PDO; or (e) the division of a tract into plots or lots used as a cemetery.

In addition, no plat shall be recorded for any division of land exempt from the PDO unless an exempt subdivision plat is prepared with the appropriate Certificate of Exemption, as shown in Appendix E of the PDO, and is signed by the Village Manager.

This application must be completed in full and submitted with the associated fee listed in the Village's Fees and Charges Schedule, which can be accessed at <u>www.vopnc.org/Home/ShowDocument?id=10100</u>.
