Jim McChesney made a motion to approve Normal Maintenance and Minor Work items; Amanda Jacoby seconded the motion, which was unanimously approved.

IV. Public Hearing;

COA 15-060 A request for a dormer addition to the rear of the home at 245 Dundee Rd., Pinehurst, NC. This property can be identified as Moore County LRK# 00016486. The applicant and property owner is Charley Griggs.

Alex Cameron, Planner read the staff report and confirmed that adjacent property owners were Notified and that the property had been properly posted.

Charley Griggs was present to answer any questions or address any concerns of the Commission.

After discussion, Amanda Jacoby made a motion to issue a Certificate of Appropriateness for the addition of the dormer in the rear of the home at 245 Dundee Road with the condition that the dormer roof matches the existing roof and that the window be 6/1 instead of the diamond cut pattern as submitted; Jim McChesney seconded the motion, which was unanimously approved. Property owner, Charley Griggs agreed with the conditions.

COA 15-62 A request for a two story addition to the rear of the home at 65 Dundee Rd., Pinehurst, NC. This property can be identified as Moore County LRK# 00022510. The applicant is Masters Properties, Inc. and the property owner is Jeffrey and Kristy Boan.

Alex Cameron, Planner read the staff report and confirmed that adjacent property owners were notified and that the property had been properly posted.

Dave Hubbard, representative of the Contractor was present to answer any questions or address any concerns of the Commission.

After discussion, the Commission stated their concerns; Dave Hubbard asked if he could contact the Contractor.

Amanda Jacoby made a motion to recess the meeting in order for Mr. Hubbard to try and contact the Contractor: Judy Davis seconded the motion, which was unanimously approved.

Mr. Hubbard was unable to reach the Contractor.

Judy Davis made a motion to reenter into the Public Hearing; Jim McChesney seconded the motion, which was unanimously approved.

After discussion, Amanda Jacoby made a motion to continue this request in order for the property owners to review the Standards and Guidelines as the Commission had concerns over the following: 1) Roof line; 2) Covering of the original siding and 3) Replacement of the windows; 4) Addition to blend and have a smooth transition; 5) Existing shutters to remain; Bob Farren seconded the motion, which was unanimously approved.
