- I. Call to Order by Mayor Nancy Fiorillo.
- II. Review notes from February 18, 2019.

The committee approved the notes from the February 18, 2019 meeting.

### III. Fire Department Program Update

Carlton Cole, Fire Chief, gave an update on the Fire Department. The Village has entered into an agreement with NCDOT to install pre-emption devices at traffic lights. These devices change the traffic lights to allow the fire trucks to move thru quickly and safely. There currently 11 traffic lights where the devices have to be installed, hopefully these lights will be completed by the end of the month.

Mr. Cole explained that the Fire Department is an accredited agency, only 19 stations in NC and 220 worldwide have this accreditation. Last year the Fire Department responded to 1,900 calls. In comparison in 2013 they responded to 216 calls. EMS, first responder calls, contribute to approximately 30% of all calls.

The Fire Department was recently awarded a grant for new long life smoke alarms to canvas Pinehurst Trace. Mr. Cole stated that the Fire Department conducts a free public CPR class at the Pinehurst Fire Station 3 times a year. They partner with surrounding municipalities to offer 1 class a month at other stations around the County, which anyone is welcomed to attend. The next class in Pinehurst is June.

The Fire Department will also come out and check and replace batteries in smoke alarms for residents for free. Mr. Cole explained that typically smoke alarms have a life of 10 years and then need to be replaced. You can call 295-5575 to have the fire department come out and check smoke alarms.

Residents can also bring their expired fire extinguishers to the station to be disposed of. Also, residents may bring their old American flags to the station to be disposed of, there is a box at the left of the front door of both stations for flags to be placed in. The Boy Scouts will dispose of the flags in a ceremony or Boles Funeral home will use them when cremating veterans.

The Fire Department also handles the File of Life Program, which is a magnet on your refrigerator that contains you pertinent information then a red dot sticker is placed on your front door so first responders know you have the information in your home. There is also a yellow dot program for your vehicle.

A committee member asked about residents burning yard debris sin Village limits. Mr. Cole stated that burning is illegal in Pinehurst. The air quality control can actually fine someone up to \$50,000. Debbie Lalor of the Downtown area asked about the laws for parking in front of fire hydrants. Mr. Cole stated that it is illegal to park within 3 feet all around the hydrants.

Mr. Cole explained that currently the Fire Department has an ISO rating of 4, for public protection classification. They have requested to be re-rated since they have become accredited agency. Typically if the rating is improved residents could see a slight decrease in their homeowners insurance.

- Lee Smith with Lawn and Tennis: Nothing to report.
- Lee Thomas of Clarendon Gardens: Aqua has said that when severe weather is expected they will stage generators in Clarendon Gardens.
- Jackie Curley of St. Andrews: Inquired about the Community Watch Program.
  Residents are concerned with the proposed changes on Highway 5. Debris on Highway 5
  from the Harness Track to the stoplight is still an issue. Residents are wondering when
  fines will be issued by the County in regards to the required valves for irrigation systems.
  The sewer leaks in Lake Pinehurst are a concern. Asked about getting the rest of St.
  Andrews paved.
- Lydia Boesch of Pinewild: They would like to see the medians planted to their Abington Lane entrance. The Home Owners Association has hired an engineer, whom has some major concerns with the Phase V development in Pinewild.
- Kay Wildt of Doral Woods: Nothing to report.
- Ed Balkovic of Pinehurst Trace: Thanked the Village for MY VOP and getting him the contact number for Duke Energy, to paint transformers in his neighborhood.
- Jan Kane of CCNC: Nothing to report.
- Charles Collini: Littering from Resort employees is still a big issue in his area.
- **Debbie Lalor of Downtown**: Thanked the Village for postponing the Long Range Comprehensive Plan and putting on a great parade. Parking was a big issue at the parade.

The parking at the Brewery is still an issue as well, as people are parking on the side of the roads.

- Beverly Reynolds of The Woodlands: Renters are a concerns in their area.
- Monica Converse of Lake Pinehurst: There are power poles on the ground around Brae Burn condominiums, looks like part of storm clean up from other agencies. Moore County had another sewage spill on March 19<sup>th</sup>. The contamination tests on the lake are showing the numbers were ok 3 days after the spill.
- Carolyn Jamison with the Pinehurst Civic Group: Nothing to report.
- Tom Campbell of Monticello: Talked about the solid waste increases that the Village is facing with Moore County and other vendors. He doesn't believe it is fair that municipalities are paying more that those that live outside municipalities. Also, in regards to the library issue, at least 90 % of the people he talked to would like to add on the current library.
- Beth Dunn, Village Clerk: Village Acres trail will be closed for five days starting next week for some repairs in the area.






