PINEHURST DEVELOPMENT **AMENDING** THE ORDINANCE AN ORDINANCE AND ZONING MAP AS IT PERTAINS TO THE REZONING OF CERTAIN LAND LOCATED ON THE EAST SIDE OF US HIGHWAY 15/501 NORTH FROM R-20 RESIDENTIAL DISTRICT/RA-40 (MOORE COUNTY ZONING) TO OFFICE PROFESSIONAL AS REQUESTED BY ALLAN CASAVANT.

THAT WHEREAS, the Village Council of the Village of Pinehurst adopted a new Pinehurst Development Ordinance and Map on the 23rd day of October, 1995, for the purpose of regulating planning and development in the Village of Pinehurst and the extraterritorial area over which it has jurisdiction; and

WHEREAS, said Ordinance and Map may be amended from time to time as circumstances and the best interests of the community have required; and

WHEREAS, a public hearing was held at 4:00 p.m. on January 25, 1999, in the Assembly Hall of the Pinehurst Village Hall, Pinehurst, North Carolina after due notice in the Pilot, a newspaper in Southern Pines, North Carolina, with general circulation in the Village of Pinehurst, and its extraterritorial jurisdiction, for the purpose of considering rezoning of land on the east side of US Highway 15/501 North from R-20 Residential District/RA-40 (Moore County zoning) to Office Professional as requested by Allan Casavant, at which time all interested citizens, residents and property owners in the Village of Pinehurst and its extraterritorial jurisdiction were given an opportunity to be heard as to whether they favored or opposed the proposed rezoning; and

WHEREAS, the Planning and Zoning Board has recommended that the zoning map be amended; and

WHEREAS, the Village Council, after considering all of the facts and circumstances surrounding the proposed rezoning, have determined that it is in the best interest of the Village of Pinehurst and the extraterritorial jurisdiction that the Development Ordinance and Zoning Map be amended as recommended by the Planning and Zoning Board.

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the Village Council of the Village of Pinehurst, North Carolina in regular session assembled on the 15th day of February 1999, as follows:

SECTION 1. That the Pinehurst Development Ordinance of the Village of Pinehurst and its extraterritorial zoning jurisdiction be and the same hereby is amended by rezoning the land on the east side of US Highway 15/501 North from R-20 Residential District/RA-40 (Moore County zoning) to Office Professional as requested by Allan Casavant

SECTION 2. That this Ordinance shall be and remain in full force and effect from and after the date of its adoption.
