AN ORDINANCE ACCEPTING PETITION FOR DEDICATION 20 11 42 AH '99 OF

ROADS IN KINGS POINT (LAKE SHORE COURT).

THAT WHEREAS, Kings Point Property Owners, own the street right-of-way in Kings Point and are desirous of dedicating said right-of-way to the Village of Pinehurst; and

Chapter 160A, Article 15, the streets and right-of-way offered for dedication by a "Declaration of Dedication - Kings Point (Lake Shore Court) Declaration of Dedication of Private Streets" the Kings Point Property Owners, duly notarized, copies of which are attached hereto and made a part hereof, the same as if included verbatim in this ordinance, are hereby accepted as public streets and right-of-way of the Village of Pinehurst, North Carolina.

SECTION 2. That this Ordinance shall be and the same is hereby effective form and after the date of its adoption.
