AN ORDINANCE ACCEPTING PETITION FOR DEDICATION OF ROADS WITHIN THE TAYLORHURST SUBDIVISION.

THAT WHEREAS, the Owners of private streets and rights-of-way in Taylorhurst Subdivision, Pinehurst, Moore County, North Carolina are desirous of dedicating said streets right-of-way to the Village of Pinehurst; and

Chapter 160A, Article 15, the streets and rights-of-way offered for dedication by a Petition of the Owners of the Taylorhurst Subdivision dated April 13, 1998, a copy of which is attached hereto and made a part hereof, the same as if included verbatim in this ordinance, are hereby accepted as public streets and right-of-way of the Village of Pinehurst, North Carolina.

That this Ordinance shall be and the same is SECTION II. hereby effective from and after the date of its adoption.

DECLARATION OF DEDICATION OF PRIVATE STREETS

This Declaration made and dedicated by and between the heirs at law of W. E. Black: Harold E. Black and wife, Ellen Black, Melba Black Vest, unmarried, Thomas Winford Black and wife, Margaret Black, Norman A. Black and wife, Patricia Black, Carolyn Black Smith, unmarried, Betty Black McKenzie, unmarried, William N. Kirk (widower of Barbara Black Kirk), Jerry Nelson Black and wife, Penney Black, hereinafter "Grantor" and the Village of Pinehurst, a North Carolina municipality, hereafter "Grantee."

WITNESSETH:

WHEREAS, Grantor is the owner of private streets in Taylorhurst Subdivision, Pinehurst, Moore County, North Carolina as shown on plats recorded in the Moore County Register of Deeds in Map Book 5, Page 25 and Plat Cabinet 2, Slide 58, Office of the Register of Deeds of Moore County, North Carolina; and
