

ORDINANCE #97-12:

AN ORDINANCE AMENDING THE CAPITAL PROJECT FUND FOR THE NEW VILLAGE HALL AND POLICE DEPARTMENT CONSTRUCTION FOR THE VILLAGE OF PINEHURST, NORTH CAROLINA.

THAT WHEREAS, the amount necessary for some appropriations in the 1996-97 Budget has changed, necessitating the addition of funds from other sources;

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the Village Council of Pinehurst, North Carolina, in regular session assembled on the 16th day of June, 1997, that, pursuant to Section 13.2 of Chapter 159 of the General Statutes of North Carolina, the following capital project ordinance is hereby amended:

SECTION 1. That the proper officers of the Village of Pinehurst are hereby authorized, empowered and directed to proceed with the project within the budgeted funds appropriated herein.

SECTION 2. The following revenues are anticipated to be available to the Village of Pinehurst to complete the project:

SECTION 8. That this Ordinance shall be and remain in full force and effect from and after the date of its adoption.
