

ORDINANCE #97-13:

AN ORDINANCE AMENDING THE ORDINANCE APPROPRIATING FUNDS FOR OPERATING EXPENDITURES OF THE GENERAL FUND FOR THE VILLAGE OF PINEHURST, NORTH CAROLINA.

THAT WHEREAS, the amount necessary for some appropriations in the 1996-1997 Budget has changed, and it has become necessary to increase certain appropriations in the 1996-1997 Budget; and

WHEREAS, the tax rate will remain unchanged;

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the Village Council of the Village of Pinehurst, North Carolina in Regular Session assembled this 16th day of June, 1997, as follows:

SECTION VI. This Ordinance is passed and adopted this 16th day of June, 1997.


