

ORDINANCE #96-3

AN ORDINANCE AMENDING THE CAPITAL PROJECT FUND FOR A PARKS AND RECREATION PROJECT, "KIDSVILLE/CAMELOT", FOR THE VILLAGE OF PINEHURST, NORTH CAROLINA.

THAT WHEREAS, the Village Council of the Village of Pinehurst previously appointed an Advisory Board to, among other things, study the long-range needs of Cannon Park; and

WHEREAS, the Parks and Recreation Advisory Board recommends that the Village proceed with the "Kidsville/Camelot" project; and

WHEREAS, after careful deliberation of the alternatives available, the Village Council has selected a site which it feels is adequate in both size and location;

WHEREAS, the amount necessary for some appropriations in the 1995-96 Budget has changed, necessitating the addition of funds from other sources;

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the Village Council of Pinehurst, North Carolina, in regular session assembled on the 19th day of February, 1996, that, pursuant to Section 13.2 of Chapter 159 of the General Statutes of North Carolina, the following capital project ordinance is hereby amended:

SECTION 1. That the proper officers of the Village of Pinehurst are hereby authorized, empowered and directed to proceed with the project within the budgeted funds appropriated herein.

SECTION 2. The following revenues are anticipated to be available to the Village of Pinehurst to complete the project:

SECTION 4. The finance officer is directed to report monthly on the financial status of this project. She shall also keep the Village Council informed at each regular meeting of any unusual occurrences.

SECTION 5. The Budget Officer is directed to include a detailed analysis of past and future costs and revenues on this capital project in every budget submission made to the Village Council.

SECTION 6. Copies of this capital project ordinance shall be made available to the budget officer, and the finance officer for direction in carrying out this project.

SECTION 7. That this Ordinance shall be and remain in full force and effect from and after the date of its adoption.

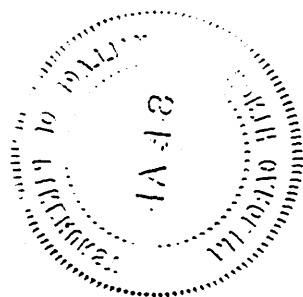
