

ORDINANCE #96-9:

AN ORDINANCE AMENDING THE ORDINANCE APPROPRIATING FUNDS FOR EXPENDITURES OF THE CAPITAL RESERVE FUND FOR THE VILLAGE OF PINEHURST, NORTH CAROLINA.

THAT WHEREAS, the purpose for which some appropriations in the 1995-1996 Budget were authorized have changed, necessitating the addition of funds from other sources; and

WHEREAS, the tax rate will remain unchanged;

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the Village Council of the Village of Pinehurst, North Carolina in a regular session assembled this 22nd day of April, 1996, as follows:

SECTION I. That the anticipated Revenues for the Fiscal Year 1995-1996 are hereby amended as follows:

SECTION V. That this Ordinance shall be and the same is hereby effective from and after the date of adoption for a period ending June 30, 1996.
