

ORDINANCE #95-30

AN ORDINANCE AMENDING THE ORDINANCE APPROPRIATING FUNDS FOR OPERATING EXPENSES FOR THE VILLAGE OF PINEHURST, NORTH CAROLINA

THAT WHEREAS, the amount necessary for some appropriations in the 1995-1996 Budget has changed, and it has become necessary to increase certain appropriations in the 1995-1996 Budget; and

WHEREAS, the tax rate will remain unchanged;

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the Village Council of the Village of Pinehurst, North Carolina in Special Session assembled this 23rd day of October, 1995, as follows:

SECTION VI. This Ordinance is passed and adopted this 23rd day of October, 1995.


