AN ORDINANCE ESTABLISHING THE PLACEMENT OF STOP SIGNS IN THE NEWLY ANNEXED AREA OF PINEHURST TRACE SUBDIVISION

THAT WHEREAS, the Village Council has the authority under Section 7-9 to direct the Police Chief of the Village of Pinehurst to erect stop signs in the corporate limits of Pinehurst; and

WHEREAS, the streets in Pinehurst Trace subdivision became part of the municipal system upon annexation on March 31st, 1994; and

WHEREAS, the need exists for erecting officially approved DOT stop signs in the subdivision;

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the Village Council of the Village of Pinehurst, North Carolina, in Regular Session assembled this 20th day of June, 1994, as follows:

SECTION 1. That Schedule VIII - Stop Intersections, of the Pinehurst Municipal Code is hereby amended by adding the following:

A STOP sign shall be installed at the Pinehurst Trace Entrance Gate at its intersection with Pinehurst Trace Drive.

A STOP sign shall be installed on Mockingbird Way at its intersection with Mockingbird Court.

A STOP sign shall be installed on Mockingbird Way at its intersection with Pinehurst Trace Drive.

A STOP sign shall be installed on Mockingbird Way at its 2nd intersection with Pinehurst Trace Drive.

A STOP sign shall be installed on Mallard Lane at its intersection with Pinehurst Trace Drive.

A STOP sign shall be installed on Turner Road at its intersection with Pinehurst Trace Drive.

A STOP sign shall be installed on Robin Lane at its intersection with Pinehurst Trace Drive.

A STOP sign shall be installed on Gull Lane at its intersection with Pinehurst Trace Drive.

A STOP sign shall be installed on Pinehurst Trace Drive at its intersection with Pinehurst Trace Drive.

A STOP sign shall be installed on Pinehurst Trace Drive Extension at its intersection with Pinehurst Trace Drive.

SECTION 2. That the Police Chief of the Village of Pinehurst is hereby authorized to erect such stop signs as outlined above.

SECTION 3. That all ordinances in conflict herewith are hereby repealed and declared null and void from and after the date of adoption of this ordinance.

SECTION 4. That this ordinance shall be and remain in full force and effect from and after the date of its adoption and the erection of the appropriate traffic signs.

SECTION 5. Adopted this 20th day of June, 1994.
