AN ORDINANCE AMENDING THE ORDINANCE APPROPRIATING FUNDS FOR OPERATIONS OF THE VILLAGE OF PINEHURST FOR FISCAL YEAR 2021, REGARDING REVENUES AND EXPENDITURES OF THE GENERAL FUND (FY 2021 CORONAVIRUS RELIEF FUNDS GRANT)

THAT WHEREAS, the Village is eligible for grant funding through Moore County from the Coronavirus Relief Fund established under the 2020 Coronavirus Aid, Relief, and Economic Security Act; and

WHEREAS, the Village is required to spend these funds on eligible COVID-19 related expenditures; and

WHEREAS, the Village has identified several eligible projects and purchases that it would like to pursue that meet the requirements of the fund and address concerns related to the ongoing pandemic; and

WHEREAS, funding must be appropriated in the budget to complete the projects; and

WHEREAS, the Village did not appropriate these funds in the original budget adopted for the year ended June 30, 2021;

NOW, THEREFORE, BE IT RESOLVED by the Village Council of the Village of Pinehurst, North Carolina, in the regular meeting assembled this 22nd day of September 2020, as follows:
