1. Call to Order.

Mayor Strickland called the meeting to order.

2. Review notes from September 21, 2020 meeting.

The committee reviewed the notes from the September 21, 2020 meeting.

3. Review Amended Nuisance Ordinance

Mayor Strickland reviewed the amended nuisance ordinance with the group. The changes include a decibel measurement level, pertain to noise, to be enforced from 10:00 p.m. to 7:00 a.m. The Police Department has purchased decibel meters to monitor the noise levels upon complaint and issue citations. Civil penalties will start at \$100 for the first infraction within a 24 month period and will escalate by \$100 for each subsequent infraction within 24 month period up to the maximum of \$500. These changes to the ordinance will become effective December 1, 2020.

Bert Higgins asked if the noise ordinance pertains to business to business violations. He also noted he would like to see loud dogs included in the decibel level measurement. Mayor Strickland stated that once the ordinance is effective Council may need to make changes as issues arise.

4. Other News

Mayor Strickland noted that Council will hold a special meeting tomorrow, October 20th, at 10:00 a.m. to review the Library Needs Assessment Survey Results and talk with the Library Consultants.

- Ernie Ferrell of Pinehurst No. 6: All is well No. 6, nothing to report.
- Jim Rooney of Pinehurst Trace: Nothing to report.
- Susan Foster of The Woodlands: Mailed out requests for voluntary memberships and had a great response. They are repairing their sign at the entrance of The Woodlands. They will be eliminating the lines in the roads when repaving Monticello.
- Bill Keith of Village Acres: Stated he was pulled over by a Moore County Deputy for going around a car at the intersection of Hwy 211 and Rattlesnake, which continues to be a troublesome intersection with frequent backups. Mayor Strickland stated the NCDOT has it on their plans and will cost around \$200,000. Bill noted that Lake View Drive was resurfaced a few months ago and portions were not completed. He would like to know if those areas not completed are on this year's resurfacing schedule. He was contacted by a resident in Village Acres about a rooster that is in the neighborhood and no one can catch it and some residents continue to feed.
- Bert Higgins of Doral Woods: They had bushes blocking the line of sight pulling out of Doral Woods and he contacted NCDOT and they came out and trimmed them back within a few days.
- Amanda Krok of Walker Station: Nothing to report.
- Tom Campbell of Monticello: Nothing to report.
- Carolyn Jamison of Pinehurst Civic Group: Nothing to report.
- Larry Rotondo of Pinewild: Nothing to report.

6. Upcoming Events

Beth Dunn, Village Clerk, shared upcoming events in the Village.

- The Beautification is conducting a Village wide Holiday Decoration contest again this year. No registration is required. Homes in gated communities are not eligible to participate. The Beautification Committee will narrow finalist the weekend of December 11th and the judge's panel will select the winners on December 15th.
- The Public Service yard, located at 700 McCaskill Road, is open through November 13th for residents to drop off their extra yard debris at no charge. The drop off area is open from 9:00 a.m. to 4:00 p.m. Monday through Friday, except holidays (11-11-20 Veterans Day). All debris should be loose and not bagged. Stumps or logs of any size are not accepted and neither are limbs exceeding either 4 feet in length or six inches in diameter.
- Early voting at the Community Center through Saturday, October 31st.
- Moore County Household Hazardous Waste/Medication Drop Off/Shredding Event on November 21st at Pinecrest High School from 10:00 am to 2:00 pm.
- The Christmas Tree Lighting is currently scheduled for December 4th. There will be more
 details forthcoming in the next few weeks on the scale of the event due to current COVID
 restrictions.
