

**ORDINANCE #20-15:**

**AN ORDINANCE AMENDING CHAPTER 72, SCHEDULE III, SCHEDULE IV, AND SCHEDULE VI OF THE PINEHURST MUNICIPAL CODE AS IT PERTAINS TO REGULATING PARKING ON THESE STREETS WITHIN THE VILLAGE OF PINEHURST, NORTH CAROLINA.**

**THAT, WHEREAS,** the Village Council of the Village of Pinehurst adopted an ordinance dated October 20, 1980, establishing and implementing certain authorized police powers for the purpose of prescribing regulations governing conditions detrimental to the health, safety, and welfare of its citizens; and

**WHEREAS,** on September 13, 2011 the Village Council of the Village of Pinehurst adopted Ordinance 11-25 which adopted the general ordinances of the Village of Pinehurst as revised, amended, restated, codified, and compiled in book form and declared that these shall constitute the “Village of Pinehurst, North Carolina Municipal Code;” and

**WHEREAS,** the Municipal Code will be subsequently amended from time to time as conditions warrant.

**NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED** by the Village Council of the Village of Pinehurst, North Carolina in a regular meeting assembled this 8<sup>th</sup> day of December, 2020 as follows:

**SECTION 1.** That the following amendments be made to Section 72.04, Parallel Parking Only:

§ 72.04 PARALLEL, **DIAGONAL, AND PERPENDICULAR** PARKING ONLY.

**(a)** No person shall park on any street shown in the Parallel Parking Only Parking Schedule, Parking Schedule III compiled under the direction of the Village Manager and kept on file in the office of the Village Clerk, unless they park on a parallel basis. (1986 Code, § 7-3.6) (Ord. 88-15, passed 10-17-1988; Ord. 90-12, passed 04-17-1990; Ord. 90-14, passed 05-21-1990) Penalty, see § 72.99

**(b)** **No person shall park on any street shown in the Diagonal Parking Only Parking Schedule, Parking Schedule IV, compiled under the direction of the Village Manager and kept on file in the office of the Village Clerk, unless they park on a diagonal basis. (1986 Code, § 7-3.7) (Ord. 90-14, passed 05-21-1990) Penalty, see § 72.99**

**(c)** **No person shall park on any street shown in the Perpendicular Parking Only Parking Schedule, Parking Schedule VI, compiled under the direction of the Village Manager and kept on file in the office of the Village Clerk, unless they park on a perpendicular basis. (1986 Code, § 7-3.7) (Ord. 20-15, passed 12-08-2020) Penalty, see § 72.99**

The Village Manager may provide temporary permission for alternate parking methods in these areas for oversized vehicles, trailers or equipment being used for current permitted construction activities, planned maintenance activities, and other activities where the Manager determines it is in the best interest of the public, tenants, and property owners to permit temporary alternate parking methods. The Village Manager is authorized to place restrictions they deem appropriate to the specific location and nature of the request.

This section does not apply to unplanned emergency response for repair and maintenance activities. This section does not apply to routine, short-term delivery and pick-up activities. See § 72.08 Loading and Unloading Zones for applicable regulations.

**SECTION 2.** That Section 72.05, Diagonal Parking Only, be removed:

**SECTION 3.** That the following amendments be made to Parking Schedules III Parallel Parking Only, IV Diagonal Parking Only, and VI Perpendicular Parking Only.

**SCHEDULE III. PARALLEL PARKING ONLY**

In accordance with the provisions of § 72.04 of the Pinehurst, North Carolina Municipal Code, no person shall park a vehicle on any of the following streets except in a parallel manner.

<i>Street</i>	<i>Side</i>	<i>Location</i>
Cherokee Road	West	On the right-of-way from 85 Cherokee Road to the corner of Cherokee and Azalea Roads
Magnolia Road	East	On the right-of-way from 60 Magnolia Road to Azalea Road
Village Green West	East	On the right-of-way from Village Chapel to the Public Sand Lot
<u>Magnolia Road</u>	<u>West</u>	<u>On the right-of-way across from Power Plant Road to 265 Magnolia Road</u>

All Streets located in the Village Commercial Zoning jurisdiction with marked or otherwise designated parallel parking spaces.

All Streets located in the Village Mixed Use Zoning jurisdiction with marked or otherwise designated parallel parking spaces.

**All Streets located in the Public Conservation Zoning jurisdiction with marked or otherwise designated parallel parking spaces.**

**SCHEDULE IV. DIAGONAL PARKING ONLY**

In accordance with the provisions of § ~~72.05~~ **72.04** of the Pinehurst, North Carolina Municipal Code, no person shall park a vehicle on any of the following streets except in a diagonal manner.

<i>Street</i>	<i>Side</i>	<i>Location</i>
Village Green East	West	On the right-of-way from Village Chapel to the Given Memorial Library

**All Streets located in the Village Commercial Zoning jurisdiction with marked or otherwise designated diagonal parking spaces.**

**All Streets located in the Village Mixed Use Zoning jurisdiction with marked or otherwise designated diagonal parking spaces.**

**All Streets located in the Public Conservation Zoning jurisdiction with marked or otherwise designated diagonal parking spaces**

(1986 Code, Ch. VII, Sch. II B) (Ord. 90-14, passed 05-21-1990) Penalty, see § 70.99 of the Pinehurst, North Carolina Municipal Code

**SCHEDULE VI. PERPENDICULAR PARKING ONLY**

**In accordance with the provisions of § 72.04 of the Pinehurst, North Carolina Municipal Code, no person shall park a vehicle on any of the following streets except in a perpendicular manner.**

**All Streets located in the Village Commercial Zoning jurisdiction with marked or designated perpendicular parking spaces.**

**All Streets located in the Village Mixed Use Zoning jurisdiction with marked or otherwise designated perpendicular parking spaces.**

**All Streets located in the Public Conservation Zoning jurisdiction with marked or otherwise designated perpendicular parking spaces.**

**Penalty, see § 70.99 of the Pinehurst, North Carolina Municipal Code**

**SECTION 3.** That this Ordinance amendment shall be and remain in full force and effect from and after the date of its adoption.
