## **ORDINANCE #22-10:**

AN ORDINANCE AMENDING THE ORDINANCE APPROPRIATING FUNDS FOR OPERATIONS OF THE VILLAGE OF PINEHURST FOR FISCAL YEAR 2023, REGARDING REVENUES AND EXPENDITURES OF THE GENERAL FUND (REAPPROPRIATE FY 2022 FUNDS IN FY 2023).

THAT WHEREAS, funds that were restricted to specific uses were received by the Village in the fiscal year ending June 30, 2022 that were not expended but are expected to be expended in the fiscal year ending June 30, 2023 including Police donations, Fire donations, Streets & Grounds donations, Recreation donations, greenway wildlife habitat donations, Police controlled substance taxes, and Police equitable sharing funds; and

WHEREAS, the Village budgeted for expenditures in the fiscal year ending June 30, 2022 for various other projects that were not incurred, but are expected to be incurred in the fiscal year ending June 30, 2023; and

**WHEREAS**, the Village did not appropriate these funds in the original budget adopted for the year ended June 30, 2023;

**NOW, THEREFORE, BE IT RESOLVED** by the Village Council of the Village of Pinehurst, North Carolina, in the regular meeting assembled this 9<sup>th</sup> day of August 2022, as follows:

**SECTION 1.** To amend the General Fund with regard to revenues and expenditures, the revenue and expenditure accounts are to be changed as follows:
