Ms. Liamcy Hogan-Rivera, NCDOT Transportation Engineer II; Ms. Karyl Fuller, Principal Planner / RPO Director for the Central Pines Regional Council; and Mr. Amar Pillai, NCDOT Transportation Engineer III (Metrolina Regional Model), were present via Zoom.

Approximately 4 audience members and 1 press in attendance.

#### I. Call to Order

Mr. Paul Sabiston, Chair and Town Manager for the Town of Aberdeen, called the meeting to order at 10:01 a.m.

II. Public Comments None.

#### III. Adjustments / Approval of the Agenda

Upon a motion by Mr. Reagan Parsons, Town Manager for the Town of Southern Pines, seconded by Ms. Melissa Adams, Town Administrator for the Town of Pinebluff, the Committee unanimously approved the September 04, 2024, Regular Meeting agenda as published by a vote of 7-0.

#### **IV.** Approval of Minutes

a. Minutes of August 07, 2024, SMPO-TCC Meeting

Mr. Reagan Parsons, Town Manager for the Town of Southern Pines, requested the August 07, 2024, SMPO-TCC Meeting Minutes be amended to reflect his attendance via Zoom.

Upon a motion by Ms. Melissa Adams, Town Administrator for the Town of Pinebluff, seconded by Mr. Jeff Sanborn, Village Manager for the Village of Pinehurst, the Committee unanimously approved the amended August 07, 2024, Regular Meeting minutes by a vote of 7-0.

#### V. General Business

#### a. NCDOT Traffic Demand Model Presentation

Mr. Amar Pillai, NCDOT Transportation Engineer III (Metrolina Regional Model), reviewed an Introduction to Travel Demand Modeling PowerPoint presentation, answered questions from the Committee on travel demand model creation and amendment timelines, and presented a model coverage map and a statewide travel model map to the Committee.

#### b. Approve Prioritization 7.0 Division points

Mr. Paul Sabiston, Chair and Town Manager for the Town of Aberdeen, and Mr. Doug Willardson, Assistant Village Manager for the Village of Pinehurst, provided background on the prioritization process for the Committee noting the SMPO has 400 points to allocate at the division level (the same amount given to the SMPO to be allocated at the regional level).

Mr. Bryan Kluchar, NCDOT Division 8 Engineer, presented a more comprehensive Prioritization 7.0 Division table, which included additional projects for consideration.

The Committee, Ms. Karyl Fuller, Principal Planner / RPO Director for the Central Pines Regional Council, and Mr. Kluchar discussed the timeline for the regional results in relation to the deadline for submission of the SMPO's allocation of the division points, available funding for projects, the possible reassignment of projects to future 5-year prioritization groupings depending on ranking and funding, projects needing a score of 25 or higher to be competitive, and the need to have support from the Governing Boards of the SMPO member municipalities for projects the SMPO allocates points to.

The Committee debated how to allocate the 400 points available for Prioritization 7.0 Division.

Upon a motion by Mr. Jeff Sanborn, Village Manager for the Village of Pinehurst, seconded by Mr. Reagan Parsons, Town Manager for the Town of Southern Pines, the Committee unanimously approved recommending the Governing Board allocate the prioritization 7.0 division points as follows by a vote of 7-0:

- 100 points to H192131: NC 211
- 100 points to H171781: NC 211 (New Route)
- 100 points to H090669: US15, US 501
- 100 points to H171727: US 1

#### VI. Other Business

Mr. Doug Willardson, Assistant Village Manager for the Village of Pinehurst, provided an update on the Request for Proposal for the Metropolitan Transportation Plan consultant, which was sent out to roughly 100 consultants with responses due back in October.

The Committee and Mr. Willardson discussed the SMPO Hiring Committee holding a meeting within the next couple of weeks and presenting options for filling the SMPO Director vacancy at the next Governing Board meeting. The Committee agreed the SMPO Hiring Committee did not need to present their options to the TCC prior to presenting them to the SMPO.

Mr. Bryan Kluchar, NCDOT Division 8 Engineer, provided an update on the Division 8 active and upcoming projects and reviewed the SMPO project table. Mr. Kluchar noted project DH00528 – Realign SR 1208 (Page Rd.) is 95% complete and will likely be removed from the Active Projects table before the next TCC meeting.

Mr. Paul Sabiston, Chair and Town Manager for the Town of Aberdeen, noted the next SMPO Governing Board meeting will be held on September 18, 2024, at 10:00 a.m. in the Assembly Hall of the Village of Pinehurst.
