SMPO Transit Information

October 31, 2024

Section 5303 Funds (Urbanized Planning Assistance) (New \$\$\$)

- Specifically for planning activities (reimbursement)
- Given to MPOs
- Must apply
- Projects must be in United Planning Work Program.
- \$67,047 80% from FTA (\$53,637), 10% from NCDOT (\$6705), 10% local match (\$6705).

Actions Required by SMPO

- Apply For Grant
- Add funding to UPWP through amendment
- Finalize agreement (docusign)

Section 5307 (Urban Transit Program) (New \$\$\$)

- Funds allocated by formula based on population
- · Funds administered directly by FTA
- Local funds match Federal funds (\$812,525). Available for 5 years.
- Operating and Capital Assistance (50/50 match), capital (80/20), very versatile funds. Vehicle purchases may request "Urban State Match" funds at 10%.
- Can be used for planning at 80/20, if so, must be added to UPWP.

Action Required by SMPO

 None, unless 5307 funds are needed for planning studies. Then the appropriate 5307 funds will need to be added to UPWP.

Section 5311 (Rural Transit Program)

- Moore County has been receiving these funds in the past
- Can pay for Demand Response, Fixed Route, Intercity Bus, etc.

Coordination only, since the area is outside of SMPO

MEMO DETAILS

Every five years, SMPO is required to produce a Metropolitan Transportation Plan (MTP) in accordance with 49 USC 5303. The first MTP for SMPO is due December 29, 2026. On November 5, a subcommittee consisting of Pam Harris (Mayor – Whispering Pines), Reagan Parsons (Manager – Southern Pines), Debra Ensminger (Moore County Planning Director), Nicholas Morrison (Federal Highway Administration), Liam Hogan-Rivera (NCDOT Transportation Planning Division), and Scott Walston (SMPO) listened to presentations by three consultants. The subcommittee members individually scored each consultant presentation based on metrics listed in the MTP RFQ approved in August. They came to a consensus on the best choice to lead this effort. That choice was approved by the TCC on November 6. Action Requested: Approve consultant selection for the Metropolitan Transportation Plan (MTP).
