## 1. Call to Order (4:30 p.m.).

Mayor Pro-Tem Lorraine A. Tweed called the meeting to order.

## 2. Motion to go into Closed Session.

Councilmember Fallon moved to recess the Work Session and enter a Closed Session pursuant to NCGS 143-318.11 (a) (3): To discuss with the Village Attorney litigation between Lydia Boesch, *et al*, v. #### - Flag Pole at Village Hall.

The Manager reported that work will begin Friday of this week or Monday of next week to move the flagpole at Village Hall to the island in front of the building.

## Improvements to Intersection at NC 2 and NC 5.

The manager reported that the work on the intersection improvements at NC 5 and NC 2 may begin as early as Friday of this week- neither of the roads will be closed for this work. He also announced that NC 5 will be closed for a week sometime during the period April 28, 2008 and late May for sandblasting and painting the railroad trestle - NCDOT will set up the detour.

#### Recycling Committee Update.

The Manager announced that the Recycling Committee will give Council an update at the next Council meeting.

#### - Council

- Councilmember Thurman complimented the employee newsletter, The P.E.N.
- Councilmember Fallon noted that the Fair Barn has received some impressive free publicity. Bride's Magazine named The Fair Barn as one of five greatest places to have a wedding, and a brochure done by Elliot's listed The Fair Barn as a great place to cater.

#### - Mayor Pro-Tem Tweed-

-reported that the Greenway Wildlife Habitat workshop which was repeated on March 29, 2008 had 70 people to attend. There will be another workshop in the fall featuring the same two speakers to address fall planting.

-announced that the Council's Downtown Decoration Committee has retained landscape designer Bart O'Connor (*pro bono*) to design some plants and hanging baskets for downtown. He will make a presentation to the Decoration Committee on April 14, 2008.

-announced that she will be making a presentation to the Business Guild at their breakfast.

-noted that the Moore County Independent sign has been removed from the hockey rink.

-reported that Larry Cox has been named chairman of the Alternate Energy Committee of the Conservation Commission. He already has a committee in place.

## 6. Presentation to Village Council by Wellhead Protection Committee.

Co-chairmen Don VanRoosen and Bill Thurman and committee member Walter Bennett of the Pinehurst Wellhead Protection Committee presented a PowerPoint program updating the Council on the status of the Pinehurst Wellhead Protection Plan and gave an analysis of the current condition of the aquifer in light of the impact of irrigation wells and over pumping of the public wells. Geologist Keith Starner of the N.C. Rural Water Association presented a PowerPoint program regarding groundwater conditions in the Pinehurst well field, making a case for wellhead protection. The Council previewed the Regular Meeting Agenda and Public Hearing items for April 22, 2008 and made no changes.

#### 11. Other Business.

## • Motion Re-appointing members of the Fireman's Relief Fund Board of Directors.

Councilmember Thurman that pursuant to NCGS 58-84-30, the Village Council appoint Mr. Robert Viall and Mr. Tim McDonald to the Fireman's Relief Fund Board of Directors for the Pinehurst Fire Department, as recommended by the Fire Chief and the Village Manager, each for two-year terms, with their terms expiring on January 31, 2010. Councilmember Fallon seconded the motion which carried unanimously by a vote of 3-0.

#### 12. Comments from Attendees.

Tom Campbell noted that in reviewing the agenda for the April 22, 2008 Regular Meeting, staff indicated they were not expecting opposition to any of the Public Hearings and stated that he was aware of opposition to the Tradition project which is the subject of two Public Hearings. Staff stated that they had been referring to the Public Hearings regarding Pinchurst Development Ordinance amendments concerning the Public Service facility.

#### 13. Adjournment.

Councilmember Fallon moved to adjourn the Work Session. The motion was seconded by Councilmember Thurman and carried unanimously. The meeting adjourned at 7:00 p.m.
