Councilmember Parson moved to recess the Regular Meeting and enter into a Public Hearing on Planning and Zoning and Other Matters. The motion was seconded by Councilmember Thurman and carried unanimously.

### Comments:

Director of Planning and Inspections Andrea Correll introduced the Public Hearing and entered into the record a statement that the proposed amendment to the Pinehurst Development Ordinance is consistent with the 2010 Comprehensive Long-Range Village Plan. (Copy of the Comprehensive Plan Consistency Statement dated April 26, 2011 is in the Minute File.)

Michael McLeod, as agent for the owners of the properties, Church of Christ of the Latter-Day Saints and Pinehurst Resorts, explained that the church wants to purchase additional property to expand their parking lot. The two parcels are zoned differently, and it made sense to have both zoned the same. The applicants are willing to limit the impervious surface on the property to 55% and to limit the use of the property to only churches.

Ms. Correll added that by code the percentage of impervious surface allowed in OP (Office Professional) is 65%. The applicants are agreeing to adhere to a lower limit on this property as a condition of the rezoning.

## 8. ADJOURN PUBLIC HEARING AND RE-ENTER REGULAR MEETING.

There being no further discussion, Councilmember Thurman moved to adjourn the Public Hearing and re-enter the Regular Meeting. Councilmember Fiorillo seconded the motion and it carried unanimously.
