### 1. CALL TO ORDER.

Mayor Nancy Roy Fiorillo called the meeting to order.

### 2. OVERVIEW.

Director of Financial Services John Frye presented an overview of the General Fund Budget discussing revenues and expenditures of the Proposed Budget for the Village of Pinehurst for the Fiscal Year Ended June 30, 2013 with historical and comparative analysis. (Copies of a more detailed agenda and a listing of funding for agencies, commissions and committees are in the Minute File.)

## 3. DISCUSSION OF REVENUES AND EXPENDITURES.

The Council discussed projected revenues and expenditures included in the 2012-2013 Budget with staff. Council decided to set aside \$100,000 for marketing of downtown retail events and general marketing of the downtown area. They also decided to remove funding for a second entrance to the Harness Track. Staff was instructed to draft an agreement with Given Library regarding the funding for the library and archives.

### 4. COMMENTS FROM ATTENDEES.

**Doug Middaugh** objected to the decrease in mileage of paving, noting that it sets a bad precedent. He also requested that Council consider abolishing the Municipal Service District tax since the tax value of the affected properties generates more revenue than the \$.05 assessment.
