The Village Council of the Village of Pinehurst held a Regular Meeting on Tuesday, November 17, 2009, at 1:00 p.m. in the Assembly Hall of the Pinehurst Village Hall, 395 Magnolia Road, Pinehurst, North Carolina with the following in attendance:

1. CALL TO ORDER.

Mayor George P. Lane called the meeting to order.

2. PLEDGE OF ALLEGIANCE AND INVOCATION.

Village Manager Andy Wilkison led in an invocation followed by the Pledge of Allegiance to the American flag led by Mayor Lane.

3. PRESENTATION.

Mayor Pro-Tem Tweed presented a Resolution and a paperweight bearing the emblem of the Pinehurst Centennial to Mr. Robert T. Hughes honoring his service as a member of the Planning and Zoning Board. (Copy of Resolution #09-25 is in the 2009 Resolution Book.)

4. APPROVAL OF CONSENT AGENDA.

All items listed below were considered routine or had been discussed at length in previous meetings and were enacted by one motion. No separate discussion was held except on request by a member of the Village Council.

Councilmember Fallon moved to approve all the items listed and considered routine on the Consent Agenda. The motion was seconded by Councilmember Tweed and the Consent Agenda was unanimously approved.

5. BUDGET AMENDMENTS REPORT TO COUNCIL.

Council noted that there were no budget amendments processed for the period October 15, 2009-November 15, 2009, and thus there is no Budget Amendment Report.

6. RECESS REGULAR MEETING AND ENTER INTO A PUBLIC HEARING.

Councilmember Thurman moved to recess the Regular Meeting and enter into a Public Hearing on Planning and Zoning and Other Matters. The motion was seconded by Councilmember Fallon and carried unanimously.

7. **PUBLIC HEARING #1:** Request for Major Site Plan Approval in order to construct a Hospitality House at 20 First Village Drive. This property is in the HD (Hospital District) Zoning District, further identified by Moore County Tax Reference as LRK # 23475. This portion of the hospital campus is currently vacant and will consist of 3.78 acres of land.

Comments:

Director of Planning and Inspections Andrea Correll introduced the Public Hearing by reading portions of the staff report concerning this request. (Copy of the staff report is in the Minute File.)

Ms. Vivian Harrington of FirstHealth explained that a hospitality house is a home that helps and heals, similar to a Ronald McDonald House. This hospitality house is planned for use by families of patients at Moore Regional Hospital. It is not a bed and breakfast; families cook there and clean their own rooms. Moore Regional Hospital has patients coming from ten surrounding counties, and finding and paying for local accommodations for families is sometimes very difficult to impossible. This hospitality house will fill that need.

Mr. Perry Harrison of The Hayter Firm explained that this project is part of First Village. He explained the plans for the building and surrounding grounds. There will be screenings behind the building plus a planned garden in that area will provide more separation and noise abatement.

Mark Reece of Rabun Architects of Atlanta showed drawings of the proposed building and explained that there will be 8 guest rooms plus 2 suites which can be separated for a maximum of 12 rooms. The building is L-shaped with a courtyard; there is a garden at the back of the lot. The building looks like a large house; it has living rooms and cooking areas downstairs with guest rooms on the second floor. He has met with the neighbors and has not received any negative responses.

Councilmember Fallon asked about the cost for guests. Ms. Harrington replied that the house is funded by donations. There will be a minimal charge to guests, perhaps \$25.00, but the cost will be determined by their ability to pay.

8. **PUBLIC HEARING #2:** Request to amend the Village of Pinehurst Official Zoning Map to include LRK #'s 35897, 31863, and 32232 in its Extraterritorial Jurisdiction (ETJ) as part of an ETJ Land Swap with the Town of Southern Pines. These properties are zoned R-30 (single family residential) and located along Midland Road. This ETJ Land Swap is also proposed to remove from the Pinehurst ETJ LRK # 36902 which is located along Airport Road.

Comments:

Director of Planning and Inspections Andrea Correll introduced the Public Hearing and entered into the record a statement that the proposed amendments to the Pinehurst Development Ordinance are

consistent with the 2003 Comprehensive Long-Range Village Plan. (Copy of the Comprehensive Plan Consistency Statement dated November 18, 2008 is in the Minute File.)

Phillip Hinsley voiced his objection to the annexation agreement because his property will be split in half. He thinks Pinehurst would want all four lots on Knoll Road.

9. ADJOURN PUBLIC HEARING AND RE-ENTER REGULAR MEETING.

Andrew M. Wilkison, Village Manager:

Andrew M. Wilkison, Village Manager:

"The floor is now open for nominations for Treasurer. Councilmembers are reminded that no second is necessary and notification should be given immediately if the nominee is unwilling to serve."

Councilmember Thurman nominated Councilmember Douglas A. Lapins.

Andrew M. Wilkison, Village Manager:

Councilmember Lapins moved to close nominations, and Councilmember Fallon seconded the motion. A voice vote closed nominations.
