ORDINANCE #13-23:

- AN ORDINANCE AMENDING SECTION 71.04 (B) AND SCHEDULE IV OF THE PINEHURST MUNICIPAL CODE AS IT PERTAINS TO SPEED LIMITS ON ALL VILLAGE STREETS WITHIN THE VILLAGE OF PINEHURST, NORTH CAROLINA.
- **THAT, WHEREAS,** the Village Council of the Village of Pinehurst adopted an ordinance dated October 20, 1980, establishing and implementing certain authorized police powers for the purpose of prescribing regulations governing conditions detrimental to the health, safety, and welfare of its citizens; and
- WHEREAS, on September 13, 2011 the Village Council of the Village of Pinehurst adopted Ordinance 11-25 which adopted the general ordinances of the Village of Pinehurst as revised, amended, restated, codified, and compiled in book form and declared that these shall constitute the "Village of Pinehurst, North Carolina Municipal Code;" and
- WHEREAS, the Municipal Code will be subsequently amended from time to time as conditions warrant; and
- **NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED** by the Village Council of the Village of Pinehurst, North Carolina in work session assembled this 28th day of May, 2013, as follows:
- **SECTION 1.** That Section 71.04 (B) SPEED LIMITS of the Pinehurst Municipal Code is amended by as follows:
- (B) The streets or parts of streets within the village, but not within the State Highway System, shall have the speed limit as posted in conformance with the provisions of § 70.04 of this code. The speed limits may be changed by ordinance as conditions warrant. All existing speed limit signs are hereby duly accepted by the Village Council as required by § 70.04 of this code. Unless otherwise posted the speed limit on all village streets or parts of streets shall be 35 25 mph.
- **SECTION 2.** That Section 71.04, Schedule IV, SPEED LIMITS of the Pinehurst Municipal Code is amended and replaced with Exhibit A.
- **SECTION 3.** That the Pinehurst Police Chief and the Public Services Director are hereby directed and empowered to erect the necessary traffic signs on the above stated roads.
- **SECTION 4.** That this Ordinance shall become in full force and effect from and after the date of its adoption and the erection of the appropriate signs.

In accordance with the provisions of § 71.04 of the Pinehurst, North Carolina Municipal Code, the following described roads within the village and the State Highway System are hereby regulated by the speed limit indicated, subject to a concurring ordinance by the Department of Transportation and the erection by the Department of Signs giving notice of the authorized speed limits, all as authorized under G.S. § 20-141(f). The speed of motor vehicles as defined in G.S. § 20-4.10(23) shall not exceed 35 25 miles per hour or as otherwise posted. These regulations shall be and remain in full force and effect from and after their adoption and NCDOT's adoption of concurring ordinances and the proper erection of signs giving notice of the authorized speed limits.
