

**ORDINANCE #12-01:**

**AN ORDINANCE AMENDING THE ORDINANCE APPROPRIATING FUNDS FOR OPERATIONS OF THE VILLAGE OF PINEHURST FOR FISCAL YEAR 2012, REGARDING REVENUES AND EXPENDITURES OF THE GENERAL FUND FOR THE VILLAGE OF PINEHURST, NORTH CAROLINA (PINEHURST PERFORMING ARTS CENTER FEASIBILITY STUDY).**

**THAT WHEREAS**, the Village Council would like to determine if a Performing Arts Center is feasible in the Pinehurst area and if the Village Center Enhancement Area (Village Place) is a feasible location for a Performing Arts Center; and

**WHEREAS**, the Village Council would further like to determine if existing cultural arts venues in the region satisfy the cultural arts needs for the Pinehurst area; and

**WHEREAS**, the Village Council would like to partner with the existing private group studying the potential of a Performing Arts Center to gather important factual information regarding such a Center; and

**WHEREAS**, on January 4, 2012 at a special Work Session, the Village Council received a proposal from Webb Management Services, Inc. to conduct a feasibility study for a Performing Arts Center in Pinehurst; and

**WHEREAS**, Phase One of the study is estimated to cost \$33,500 and no funds were budgeted for the proposed study in the FY 2012 Budget;

**NOW, THEREFORE, BE IT RESOLVED** by the Village Council of the Village of Pinehurst, North Carolina, in work session assembled this 10<sup>th</sup> day of January 2012, as follows:

**SECTION 1.** To amend the FY 2012 General Fund budget with regard to revenues and expenditures, the revenue and expenditure accounts are to be changed as follows:




