## **ORDINANCE #12-29:**

## AN ORDINANCE AMENDING THE PINEHURST MUNICIPAL CODE AS IT PERTAINS TO CARRYING CONCEALED WEAPONS.

- **THAT, WHEREAS,** the Village Council of the Village of Pinehurst adopted an ordinance dated October 20, 1980, establishing and implementing certain authorized police powers for the purpose of prescribing regulations governing conditions detrimental to the health, safety, and welfare of its citizens; and
- WHEREAS, on September 13, 2011 the Village Council of the Village of Pinehurst adopted Ordinance 11-25 which adopted the general ordinances of the Village of Pinehurst as revised, amended, restated, codified, and compiled in book form and declared that these shall constitute the "Village of Pinehurst, North Carolina Municipal Code;" and
- **WHEREAS**, the Municipal Code will be subsequently amended from time to time as conditions warrant; and
- WHEREAS, North Carolina General Statute §14 415.23 authorizes municipalities to adopt an ordinance to permit the posting of a prohibition against carrying a concealed handgun, in accordance with G.S. §14 415.11(c) on local government buildings and their appurtenant premises;
- **WHEREAS**, the Village Council of the Village of Pinehurst desires to repeal Ordinance 12-24 adopted on July 24, 2012 as it relates to the Carrying of Concealed Weapons;
- **NOW THEREFORE, BE IT ORDAINED AND ESTABLISHED** by the Village Council of Pinehurst, North Carolina, in work session assembled this 21<sup>st</sup> day of August, 2012 as follows:
- **SECTION 1.** That Section 94 of the Village of Pinehurst, North Carolina Municipal Code is hereby amended by deleting in its entirety Section 94.26 as it pertains to the prohibition on Carrying of Concealed Weapons;
- **SECTION 2.** That Section 130.02 (A) *Findings*, of the Village of Pinehurst, North Carolina Municipal Code regarding the Posting of Signs Prohibiting Carrying of Concealed Weapons is hereby amended by deleting the words "and parks" from language contained therein;
- **SECTION 3.** That Section 130.02 (B) *Posting of Signs required*, of the Village of Pinehurst, North Carolina Municipal Code regarding the Posting of Signs Prohibiting Carrying of Concealed Weapons is hereby amended by deleting the words "each park and" from language contained therein;
- **SECTION 4.** That Section 130.02 (C) *Location of Signs*, of the Village of Pinehurst, North Carolina Municipal Code regarding the Posting of Signs Prohibiting Carrying of Concealed Weapons is hereby amended by deleting the words "and parks" from language contained therein.

**SECTION 5.** That all local ordinances in conflict herewith are hereby repealed and declared null and void from and after the date of adoption of this ordinance.

**SECTION 6.** That this Ordinance shall be and remain in full force and effect from and after the date of its adoption.
