## **ORDINANCE #11-09:**

AN ORDINANCE AMENDING THE ORDINANCE APPROPRIATING FUNDS FOR OPERATIONS OF THE VILLAGE OF PINEHURST FOR FISCAL YEAR 2011, REGARDING REVENUES AND EXPENDITURES OF THE GENERAL FUND FOR THE VILLAGE OF PINEHURST, NORTH CAROLINA (PHONE SYSTEM)

**THAT WHEREAS**, the phone system used Village-wide has reached its maximum useful life and was identified for replacement in FY 2013 in the 2012-2016 CIP; and

WHEREAS, the FY 2011 budget includes funds to upgrade the Fire Department's radio system, which has been postponed to FY 2012, as well as funds for a SAN storage system, Police phone system, and other available operating funds; and

WHEREAS, the Information Technology Department would like to reallocate the \$72,666 identified above to replace the Village-wide phone system this fiscal year.

**NOW, THEREFORE, BE IT RESOLVED** by the Village Council of the Village of Pinehurst, North Carolina, in work session assembled this 26<sup>th</sup> day of April, 2011, as follows:

**SECTION 1.** To amend the FY 2011 General Fund budget with regard to revenues and expenditures, the revenue and expenditure accounts are to be changed as follows:
