

ORDINANCE #10-57:

AN ORDINANCE AMENDING THE PINEHURST MUNICIPAL CODE AS IT PERTAINS TO CHAPTER VII, SCHEDULE VA- TRUCKS PROHIBITED CERTAIN STREETS AND SCHEDULE IA- LOADING AND UNLOADING ZONES.

THAT, WHEREAS, the Village Council of the Village of Pinehurst adopted an ordinance dated October 20, 1980, establishing and implementing certain authorized police powers for the purpose of prescribing regulations governing conditions detrimental to the health, safety and welfare of its citizens; and

WHEREAS, the Municipal Code has been subsequently amended from time to time as conditions warrant;

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the Village Council of the Village of Pinehurst, North Carolina, in work session assembled this 16th day of November, 2010, as follows:

SECTION 1. That the Pinehurst Municipal Code is be and the same is hereby amended by adding the following text amendment to Chapter 7, Schedule VA:

SCHEDULE VA
TRUCKS PROHIBITED CERTAIN STREETS

In accordance with subsection 7-4.3, all trucks and trailers are prohibited from the parts of streets as described in this schedule, except for the pickup or delivery of materials on that street, not to include the areas regulated by schedule IA.

Barrett Road, from Fields Chinquapin Road through Highway #5.

Cherokee Road, a) ~~the one way street in front of the Post Office;~~ b) from Fields Road through Highway #5 **to the intersection of Cherokee Road and NC 2.**

Chinquapin Road, from Fields Cherokee Road through Highway #5 **to the end of Chinquapin Road at the intersection of Magnolia Road and Dogwood Road, not to include areas regulated by schedule IA.**

SECTION 2. That the Pinehurst Municipal Code is be and the same is hereby amended by adding Schedule IA- Loading and Unloading Zones, to read as follows:

SCHEDULE IA LOADING AND UNLOADING ZONES

In accordance with the provisions of subsection 7-3.1, no person shall park a vehicle, van or truck for delivery purposes upon any of the following areas between the

time period of 11:00 AM and 2:00 PM, except in areas that have been clearly signed and dedicated as loading and unloading areas by the Village of Pinehurst.

- Within any street or right of way located within the VC (village commercial) zoning district or any street or right of way immediately adjacent to the VC zoning district.

In addition, parking for loading and unloading shall comply with the following provisions:

- Parking within the dedicated loading and unloading zones shall be limited to 30 minutes
- No one shall park in a loading and unloading zone unless they are actively loading or unloading cargo.
- No vehicle being loaded or offloaded may be left idling for more than five (5) minutes in the same location.

SECTION 3. That this Ordinance shall be in full force and effect from and after the date of its adoption.
