#### **ORDINANCE #09-23:**

# AN ORDINANCE ACCEPTING DECLARATION OF PUBLIC DEDICATION FOR STREETS IN LAMPLIGHTER VILLAGE.

**THAT WHEREAS,** General Buster C. Glosson owns the streets and right-of-way in Lamplighter Village of Pinehurst, LLC and is desirous of dedicating said right-of-way and roads/streets to the Village of Pinehurst; and

WHEREAS, General Buster Glosson has presented a "Declaration of Public Dedication for Streets of Lamplighter Village of Pinehurst" requesting such dedication to the Village of Pinehurst; and

WHEREAS, General Buster C. Glosson has agreed in a letter dated July 10, 2009 to warrant all street pavement material and workmanship provided by S. T. Wooten Corporation for the project at Lamplighter Village located on Juniper Creek Boulevard in Pinehurst for a period of twenty-four (24) months from the date of acceptance; and

WHEREAS, the recorded plat for the development known as Lamplighter Village of Pinehurst depicts the roads within the subdivision as being dedicated for public use; and

WHEREAS, Resolution #09-16, adopted by the Village Council of the Village of Pinehurst in their regular meeting held on April 28, 2009, changed the name of "Lamplighter Village Circle" to "Lamplighter Village Drive" resulting in their being only two streets in the Lamplighter Village subdivision- Lamplighter Village Drive and Lamplighter Village Court; and

WHEREAS, the Village Council of the Village of Pinehurst has, to this date, not officially accepted the proposed dedication of these streets; and

**WHEREAS**, the Village of Pinehurst maintains all village owned streets open to general public use within the corporate limits, and receives an annual allocation of the State gasoline tax to maintain such streets;

**NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED**, by the Village Council of the Village of Pinehurst, North Carolina in work session assembled this 28<sup>th</sup> day of July, 2009, as follows:

**SECTION 1.** That, pursuant to N.C.G.S. Chapter 160A, Article 15, the roads/streets and right-of-way offered for dedication by a "Declaration of Public Dedication for Streets of Lamplighter Village of Pinehurst," of General Buster Glosson, dated July 16, 2009, a copy of which is attached hereto and made a part hereof, the same as if included verbatim in this ordinance, are hereby accepted as public roads/streets and right-of-way of the Village of Pinehurst, North Carolina.

**SECTION 2**. That this Ordinance shall be and the same is hereby effective form and after the date of its adoption.

# DECLARATION OF PUBLIC DEDICATION FOR STREETS OF LAMPLIGHTER VILLAGE OF PINEHURST
