

**ORDINANCE #08-07:**

**AN ORDINANCE AMENDING SCHEDULE IV OF SECTION 7-3.5 OF THE PINEHURST MUNICIPAL CODE AS IT PERTAINS TO PARKING IN THE VILLAGE OF PINEHURST**

**THAT WHEREAS**, the Village Council has established parking regulations throughout the corporate limits; and

**WHEREAS**, the Village Code of Ordinances gives the Village Council the ability to create and provide parking in public rights-of-way; and

**WHEREAS**, the Village's Municipal Code currently indicates that parking on designated Village streets is allowed subject to certain designated time limits; and

**WHEREAS**, changing conditions have required review of certain parking areas; and

**WHEREAS**, a study was conducted by Village staff analyzing the costs and benefits of continuing the regulation of overtime parking in the Core Village;

**NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED** by the Village Council of Pinehurst, North Carolina, in work session assembled this 11th day of March, 2008 as follows:

**SECTION 1.** That Schedule IV of Section 7-3.5 of the Pinehurst Municipal Code is hereby amended as follows:

**SECTION 2.** That all ordinances in conflict herewith are hereby repealed and declared null and void from and after the date of adoption of this ordinance.

**SECTION 3.** That this Ordinance shall be and remain in full force and effect from and after the date of its adoption and removal of the appropriate traffic signs.
