## **ORDINANCE #08-22:**

AN ORDINANCE AMENDING CHAPTER 7, SCHEDULE X OF THE PINEHURST MUNICIPAL CODE AS IT PERTAINS TO REGULATING TRAFFIC ON CERTAIN ROADS WITHIN THE VILLAGE OF PINEHURST, NORTH CAROLINA.

THAT WHEREAS, the Village Council of the Village of Pinehurst adopted an Ordinance dated October 20, 1980, regulating various traffic controls for the purpose of prescribing regulations governing conditions hazardous to life and property or detrimental to the safety or welfare of its citizens; and

WHEREAS, the Municipal Code has been subsequently amended from time to time as conditions warrant; and

WHEREAS, the Village Council has received a written request from the Village Acres of Pinehurst Property Owners Association, and from twenty-five residents of Lake Hills Road, to lower the speed limits throughout the Village Acres community and on Lake Hills Road from 35 to 25 mph;

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the Village Council of the Village of Pinehurst, North Carolina in work session assembled this 12<sup>th</sup> day of August, 2008, as follows:

**SECTION 1.** That Schedule X of Chapter 7, SPEED LIMITS of the Pinehurst Municipal Code, is amended by adding the following roads:

**SECTION 2.** That Schedule X of Chapter 7, SPEED LIMITS of the Pinehurst Municipal Code, is amended by adding the following road.

Description LAKE HILLS RD

Speed Limit 25

**SECTION 3.** That the Pinehurst Police Chief and the Public Services Director are hereby directed and empowered to erect the necessary traffic signs on the above stated roads.

**SECTION 4.** That this Ordinance shall become in full force and effect from and after the date of its adoption and the erection of the appropriate signs.
