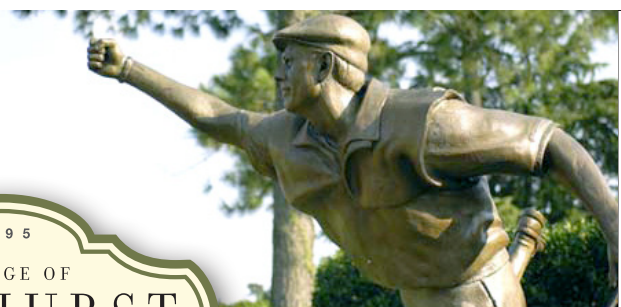

The Village of Pinehurst and the United States Golf Association (USGA) are proud to announce plans for the U.S. Open Experience which includes interactive programming and spectator entertainment during the upcoming historic 2014 U.S. Open Championships. Residents and visitors alike are invited to participate in the U.S. Open Experience in the heart of the Village at Tufts Park. The U.S. Open Experience will include two weeks of special events with free admission to the public including live musical performances, round table discussions, golf films, and interactive golf experiences. These events are intended to ensure both residents and visitors enjoy a memorable experience, our Village businesses prosper, and our guests leave wanting to return to the Village of Pinehurst.

Conveniently located in Tufts Park in the Village Center, the U.S. Open Experience festivities will begin in the early evenings at the conclusion of daily practice or championship play and will conclude no later than 10:30pm to comply with the local noise ordinance. Tufts Park will be the site of a large tent-covered stage, a 9-by-12

foot LED screen, folding chairs, rocking chairs, and table seating. Food and beverage vendors, a putting green, and live streaming of the championships will be the main attractions during the day for those individuals hoping to experience the U.S. Open Championships outside of the gates. Each day WNCN will be reporting news live from Tufts Park from 11:00am-12:00pm. During the final championship days, the LED screen will stream live coverage of the championships. Due to limited parking in the Village, the Village of Pinehurst and the USGA encourage everyone to park in Lot G at Cannon Park while evening events are being held. Please note that Lot G (Cannon Park) will not be available for public parking during the day as this is a restricted area

requiring a parking pass. The Cannon Park lot and complimentary shuttles will be available on the nights of scheduled events. Shuttles will run from 6:00pm until 10:30pm for safety and convenience. Lot G (Cannon Park) will not be available for public parking on the evenings of Monday, June 9; Sunday, June 15; Tuesday, June 17; and Sunday, June 22.

Organizers of Pinehurst Live After 5 will provide a free music event in the Village Center the weekend prior to the 2014 U.S. Open Championships. This event will be held on Saturday, June 7th from 2:00pm to 9:00pm and will feature three bands: The McKenzie Brothers, The Sand Band, and Carolina Soul Band. Food and beverages will be available for purchase on site. Pinehurst Parks & Recreation will host games and activities for the kids during the event. Residential Regulations

During the weeks of the U.S. Open Championships the Village anticipates the use and rental of private residential homes for lodging and hospitality. Residents who plan to rent their homes should be aware of applicable health and safety regulations and recognize that outside organizations or groups using their property will need to comply with all applicable Village and state codes. All violations of regulations will be the responsibility of the property owner. Below are a few reminders:

Noise Ordinances: Please be aware that the noise ordinance within the Village of Pinehurst will be enforced between the hours of 11:00 p.m. and 7:00 a.m.

Parking Lot Concessions: The Village does not permit the use of private property as a parking lot. This prohibition is necessary to control traffic and prevent gridlock on Village roads. It will also enhance the

convenience and safety of the residents and visitors throughout Pinehurst.

Tents on Property: A permit and inspection are required for tents with any dimension greater than twelve (12) feet. Please call the Village of Pinehurst Planning and Inspections Department (910-295-2581), as the state building code and fire codes regulate tents, the occupancy of public spaces, and other building code issues.

Other Temporary Structures on Property: Please call the Village of Pinehurst Planning and Inspections Department (910-295-2581) to notify staff of these structures and to determine necessary permits or inspections that will need to be completed. Please note that Recreational Vehicles (RVs) are not permitted within residential neighborhoods in the Village of Pinehurst. 🌿

Village Services Will Continue During U.S. Open Championships

Regular municipal services in Pinehurst will continue during the weeks of the 2014 U.S. Open Championships. This includes fire, police, solid waste collection, recycling, yard debris collection, and building inspections. The Village Hall will be open and Village personnel will be on duty as usual. Village staff intends to carry on with business as usual for the citizens of Pinehurst.

Please be reminded to store your solid waste carts in the designated locations in a timely manner to keep the Village looking pristine, especially for these two weeks as Pinehurst is on the world stage.

Parks and Recreation Facilities

The Village of Pinehurst Parks and Recreation facilities will have limited availability during the weeks of the U.S. Open Championships. Camelot Playground will be open in Cannon Park as will part of the parking lot closest to the playground. The Wicker Park hockey rink, playground, and tennis/pickle ball courts will also be open and the parking area between these three amenities will remain open for the park patrons. 🌿

Temporary Ordinances for the U.S. Open Championships

The Pinehurst Village Council recently passed several temporary ordinances that will be in effect during the 2014 U.S. Open Championships.

Open Container Law

During June 7- 22, 2014, possession and consumption of beer and wine will be allowed on any property owned, occupied, or controlled by the Village (excluding public streets open to regular traffic) as identified on the adopted map. Please be reminded to recycle using the receptacles provided throughout the Village. A map of the area where open containers will be allowed can be found on the Village website (www.vopnc.org/2014usopens).

3-Hour Parking Restriction

A new 3-hour public parking time limit will be enforced in the Village Center from June 9-16, 2014 between the hours of 9:00am and 6:00pm. Violators will be fined \$50 for exceeding these time limits and the Citizens on Patrol will monitor parking throughout the day. The Village Green parking lot will be restricted to employees of Village Center businesses.



No Parking on Certain Roads and Roads Closing

The Village of Pinehurst has established an on-street parking prohibition on the listed roads during the timeframe of the U.S. Open Championships. This is to prevent cars from parking along the roads in the neighborhoods that are within close proximity of the event.

These roads are: Azalea Road, Campbell Road, Cherokee Road, Chinquapin Road, Community Road, Craig Road, Dalrymple Road, Dundee Road, Everett Road, Fields Road, Kelly Road, Laurel Road, Magnolia Road, McIntyre Road (Woods Road to Short Road), Monticello Drive (Hwy #5 to Blake Blvd.), Palmetto Road, Shaw Road SE, Short Road (East and West of Page Road), and Woods Road.

Also, certain roads throughout the Village located within close proximity of the U.S. Open Championships will be closed to thru-traffic as requested by the USGA. The intersection of Pine Tree Road and NC-5 will be closed beginning at 12:01 a.m. on Monday, June 9. Access to and from Pine Tree Road will only be allowed from St Andrews Road. Residents of condominium complexes with driveway access off of Pine Tree Road will be issued a resident pass by their condo association to access their homes during this time.

Morganton Road will be closed from NC-5 to Doral Drive beginning at 6:00 p.m. on Sunday, June 8. All residents living west of the Morganton Road/Monticello Drive intersection will be issued a resident parking pass. Parking passes must be visible to law enforcement officers in order to proceed through the Morganton Road/Monticello Drive intersection. There will be no thru traffic or access to Morganton Road from NC-5 during the championships. Monticello Drive will serve as the detour route. 🌿

Transportation, Parking, Golf Carts, and Gates

Transportation and Parking: In conjunction with the North Carolina State Highway Patrol, Village of Pinehurst Police Department and other local and state agencies, the United States Golf Association has developed a parking and transportation plan for the historic U.S. Open Championships to be played at Pinehurst Resort and Country Club June 9 through June 22, 2014. The plan was designed to ensure the safe and efficient movement of traffic and pedestrians during the championships.

Moore County residents should utilize one of two satellite parking areas unless they can walk to the championship or reach one of three golf cart parking areas. Residents can also make use of the Taxi/Limo/Passenger drop-off at the former site of the World Golf Hall of Fame located off of NC-2. Access to the Taxi/Limo/Passenger drop-off is limited to vehicles no larger than 12 passengers. Parking in the Village of Pinehurst will be closely monitored and parking regulations will be strictly enforced. There will be no championship parking for general spectators within the Village of Pinehurst.

For the week of the U.S. Open (June 9-15), complimentary parking will be available in TWO general spectator parking lots.

- Spectators residing north of NC-211 and NC-2/ Midland Road are encouraged to utilize The RED Lot (North). The RED Lot will be accessible from US-15/501 via NC-73 West. From NC-73 West, follow signage to the parking lot.
- Spectators residing south of NC-2 and east of NC-5 should use the BLUE Lot (South). Traffic

should follow US-1 South to Roseland Road and follow signage to the parking lot.

- Residents south of NC-211 and west of NC-5 should follow NC-5 South to US-15/501 and US-1 South to utilize the BLUE Lot (South).

A total of 130 buses will provide complimentary transportation from the RED Lot and BLUE Lot each day. Shuttles will operate from each parking lot from 5:30 a.m. to 9:00 p.m. throughout the week. More than 100 NC State Highway Patrol officers, along with local law enforcement agencies will be posted throughout the area to assure a safe and efficient flow of traffic.

For the week of the U.S. Women's Open (June 17-22), complimentary parking will be available at the BLUE Lot (South) ONLY. Complimentary shuttles will be available from 5:30 a.m. to 9:00 p.m. for the duration of the U.S. Women's Open Championship. Residents should follow trail signage from their respective area to the BLUE Lot.

The Taxi/Limo/Passenger drop-off will continue to operate at the site of the former World Golf Hall of Fame located off of NC- 2. Access to the Taxi/Limo/Passenger drop-off will continue to be limited to vehicles carrying no more than 12 passengers. The drop-off location is located in close proximity to Gate 3.

Due to U.S. Open traffic, delays can be expected during peak arrival and departure times (7-11am and 3:30-7:30pm). Shuttle traffic is expected to be heavy along the primary routes in and around Pinehurst Resort and Country Club.

Golf Cart Parking: Local residents living in close proximity to Pinehurst Resort and Country Club may use one of three golf cart designated parking areas:

- For residents who live west of NC-5, parking will be located by the 2nd tee of Course No. 3 and No. 5.
- For residents of Fairwoods on 7, golf cart parking is allowed behind the 14th green and adjacent to the admission gate behind the 9th green of Course No. 2.
- For residents of Doral Woods and Monticello Road, golf cart parking will be provided on the 3rd hole of Course No. 1.
- For residents living north of the Pinehurst Traffic Circle (Village Acres of Pinehurst and Pinehurst No. 6) it is recommended that you not use personal golf carts for transportation during the championships.

Private golf carts will not be allowed on the championship grounds.

Admission Gates: There will be three public admission gates for ticket holders to access the course. Gate 1 will be the main admission gate located off Morganton Road near the Harness Track. All spectators utilizing the general spectator parking lots will enter through this gate. Gate 2 will be located on club property on Carolina Vista Drive. Gate 3 will be located at the Taxi/Limo/ Passenger Drop-Off at the former site of the World Golf Hall of Fame off of Midland Road (NC-2). 🌿
