Village to Facilitate Regional Water/ Wastewater Partnership

In July the Village of Pinehurst announced its plans to acquire the water and wastewater plants of the former WestPoint Pepperell mill facilities near Wagram, N.C.

For \$5.5 million, the Village will acquire a water treatment plant, wastewater treatment plant, a raw water intake, and 198 acres of land on the Lumber River that formerly served the West Point Pepperell textile mill near Wagram, NC in Scotland County.

Securing an adequate water

supply for Pinehurst residents is one of the key objectives outlined in the Village Council's Comprehensive Long Range Plan. In fact, 87% of residents participating in a telephone survey "felt that Pinehurst needed to develop more water supply sources."

Pinehurst has experienced numerous water restrictions because of a lack of water availability, which has had a negative impact on the quality of life for Pinehurst residents and the local economy. The Carolina Hotel has had to serve guests on disposable paper products, the hospital has had to drill private wells to ensure a stable water supply, and residents have been restricted from using water outdoors.

The 2008 McGill Water Source Evaluation and Plan proposed the WestPoint facilities as a potentially viable means of providing additional water to Moore County. Because the facilities are in the same river basin as Southern Moore County, the reuse of water within the same basin does not require a costly and time consuming inter-basin transfer (IBT) permit, as would be required to transfer water from other parts of Moore County.

Today, the water treatment plant is producing processed water and treating wastewater for a local industrial customer, Gullistan Carpets. Water quality testing indicates the facilities are capable of producing potable water for residential consumption.

The facilities are capable of producing and

treating 7 million gallons of water per day.

Based on a preliminary engineering study, upgrades to realize the full rated capacity of each plant and modernize the facilities could be

> approximately \$15 to \$20 million per plant.

The Village intends to partner with other jurisdictions in the region who would like to secure a long-term water/wastewater solution for their communities. To that end, the Village intends to facilitate the formation of an

entity that will oversee the provision of water and wastewater services to the region.


Jurisdictions that could partner with the Village include Aberdeen, Laurinburg, Maxton, Moore County, Pinebluff, Raeford, Red Springs, Scotland County, and Southern Pines. The partners in the regional consortium would share in the cost of any plant upgrades and the installation of transmission lines.

Upon approval of the sale by the Scotland County Commissioners, the Village will secure financing to purchase the WestPoint assets and will also be actively working towards forming a regional consortium in the next several months.

Pinehurst Elementary Constructs a Fitness Trail

Thanks to a generous grant from Lowe's Home Improvement, Pinehurst Elementary celebrated the opening of their new fitness trail with a Ribbon Cutting Ceremony in June. This was one of the biggest pieces of the Pinehurst Elementary School Garden Master Plan. Lowe's District Manager, David Hodges and Joseph Skipper, Lowe's Aberdeen Store Manager attended the Ribbon Cutting Ceremony. The 1/7 mile trail is open to the public on weekends and evenings.

The fitness trail is the most recent addition to the gardens that were created in early July 2008. A FirstSchool vegetable garden was built in September 2008 to teach children about healthy eating. Funding for the materials came from Communities in Schools (CIS), Moore Regional Hospital Auxiliary and Blue Cross Blue Shield Foundation. Classes began to rotate through the garden once a week in September with NC Cooperative volunteer, Bruce Fensley, and CIS's Garden Coordinator, Kathy Byron.

In May, Pinehurst Elementary was awarded a beautification grant from the Village of Pinehurst to install a wall of shrubs

to protect the children from Dundee Road. At the same time, a main entrance was built with the generous support of Bart O'Connor and Design Company. Two beautiful conifer trees were donated for the entrance by the Pinehurst Conservation Committee on Arbor Day.



T.R.Y. Weekly and Recycling

T.R.Y. Weekly, which was implemented in July, has been very well received in the Village and recycling participation is on the rise. As a reminder, T.R.Y. Weekly refers to the switch to collecting household trash, recycling and yard debris once each week. Few problems have risen with the switch, and for those who recycle the addition of weekly recycling collection has been very well received.

With recycling collected more frequently, now is the perfect time to jump on the bandwagon and start recycling. Recycling in the Village is really quite easy as you can place all recyclable items in one single bag or container and place them curbside on the appointed day for collection. It's that simple. No need to sort or separate.

It's estimated that at least 40% of household trash is recyclable. By volume, it may actually be higher as a lot of what is recyclable is packaging, cartons and containers that take up a lot of space in the trash receptacle (and the landfill). A list of recyclable items that are accepted by the Village is listed below. Once you start recycling, you'll quickly see just how much of what you throw away can be diverted from the landfill so don't delay, get started today!

Recyclable Items

- Paper (junk mail, newspapers, white and colored paper, envelopes, magazines, catalogs, office paper, pamphlets, brochures, letterhead, stationary, posters, greeting cards, etc.)
- Corrugated cardboard
- Chipboard cardboard (cardboard food packaging like cracker boxes, cereal boxes, 12 packs soda boxes, etc.)
- Plastics with numbers 1-7
- Metal cans
- Tin cans
- Aluminum cans
- Glass (clear and colored) bottles

- What we need to support the kind of community we want to be (such as water supply roadway capacity, and community facilities)



Pinehurst Fire Chief Jimmy McCaskill Retires After 34 Years With Village

After thirty-four years of service to the Village of Pinehurst, Fire Chief Jimmy McCaskill will retire on September 30, 2009.

Starting as a rookie fireman in 1975, Jimmy has served the Village faithfully while working his way up the ranks, eventually becoming Chief in 2005. Prior to becoming Chief, Jimmy also served as Lieutenant, Captain and Deputy Chief.



Over the years, Jimmy has witnessed and helped lead the Village through tremendous change, not only within the Fire Department, but also in the wider community as the population grew from approximately 1,000 to today's 11,900. During his career, a building boom occurred that saw the Resort and Hospital become major campuses with complex construction and protection needs, the Village weathered the myriad natural and man-made occurrences that make the life of a public safety official interesting, and he oversaw the construction of a new firestation.

During Jimmy's tenure, he volunteered for extended tours of duty in Eastern North Carolina fighting wildfires, in Louisiana assisting FEMA with recovery efforts after Hurricane Katrina, and he presently volunteers as a Camp Counselor at Camp Celebration in North Carolina, where children who are burn victims spend time each summer enjoying summer camp opportunities they may otherwise not get to experience.

Village Manager Andy Wilkison stated, "Jimmy McCaskill was the natural selection for Fire Chief in 2005 when the opening occurred, and there has not been a more dedicated, loyal, and self-giving Department Head than Chief McCaskill. Jimmy could always be relied upon to lead the Village and the Fire Department in the tough times and the good times. He exhibited great leadership in all kinds of circumstances, whether the situation called for recovery from a hurricane, a winter ice storm, a tornado or twenty-four inches of snow. He will be missed tremendously, though he leaves the Fire Department in outstanding shape."

Jimmy is an avid hunter and fisherman, and will also spend time with his five grandchildren in his richly deserved retirement years. Deputy Chief Floyd Fritz will serve as Interim Fire Chief while the Village conducts a search for Chief McCaskill's replacement.



Pinehurst was given a grade of a "B." Joseph Coletti, John Locke Foundation Fiscal and Health Care Policy Analyst, said, "No local entity earned an A initially but several offered enough online access to information to earn B grades."

The results of their ratings are posted at <u>www.nctransparency</u>. com. NCTransparency.com is a Web site produced by the John Locke Foundation in an effort to promote transparency in North Carolina. It connects citizens to important information available online about state agencies, counties, school systems and municipalities. They determined there are 24 important baseline documents or reports that, at the least, should be available to citizens and taxpayers.

"When applied to government, transparency means being able to see what elected representatives and bureaucrats are doing with the tax money they take from citizens," says Coletti. "In the age of the Internet and digital technology, citizens are demanding their state, local and national governments provide online access to the basic information they must have in order to make decisions as responsible citizens."



Fire Department Completes Installation of Drafting Pit

In the spring of this year, the Pinehurst Fire Department installed a new drafting pit. This pit was installed so the department can conduct annual tests on hoses, ladders and pumping apparatus to meet certification requirements. Ladders are tested at the fire station, fire hoses are tested on Rassie Wicker Road next to the fire station, but pumper trucks must be taken to a static water source such as a lake or pond to be tested. In past years the Pinehurst Fire Department had to depend on the generosity of neighboring communities to meet the testing requirements for pumper trucks.

During the planning of the new main fire station, staff identified the need for a drafting pit and designated an area for its future construction. The department received funding in the 2009 budget for the drafting pit, and members of the fire department recently completed the installation with assistance from other Village departments.

The drafting pit consists of a 23,000 gallon below-ground tank filled with water plus a concrete pad for parking the fire truck. The truck captures and recycles the water.

An additional benefit of having the tank at the fire station is that the annual tests can be conducted using on-duty personnel.

Before the drafting pit was constructed, a crew would need to be taken out of service for the couple of hours required to test each truck, or off-duty personnel would be used. The pit will also be used for pump operation training for new driver/operators.



Fire Department Completes Installation of Drafting Pit

In the spring of this year, the Pinehurst Fire Department installed a new drafting pit. This pit was installed so the department can conduct annual tests on hoses, ladders and pumping apparatus to meet certification requirements. Ladders are tested at the fire station, fire hoses are tested on Rassie Wicker Road next to the fire station, but pumper trucks must be taken to a static water source such as a lake or pond to be tested. In past years the Pinehurst Fire Department had to depend on the generosity of neighboring communities to meet the testing requirements for pumper trucks.

During the planning of the new main fire station, staff identified the need for a drafting pit and designated an area for its future construction. The department received funding in the 2009 budget for the drafting pit, and members of the fire department recently completed the installation with assistance from other Village departments.

The drafting pit consists of a 23,000 gallon below-ground tank filled with water plus a concrete pad for parking the fire truck. The truck captures and recycles the water.

An additional benefit of having the tank at the fire station is that the annual tests can be conducted using on-duty personnel. Before the drafting pit was constructed, a crew would need to be taken out of service for the couple of hours required to test each truck, or off-duty personnel would be used. The pit will also be used for pump operation training for new driver/operators.

Village to Facilitate Regional Water/ **Wastewater Partnership**

In July the Village of Pinehurst announced its plans to acquire the water and wastewater plants of the former WestPoint Pepperell mill facilities near Wagram, N.C.

For \$5.5 million, the Village will acquire a water treatment plant, wastewater treatment plant, a raw water intake, and 198 acres of land on the Lumber River that formerly served the West Point Pepperell textile mill near Wagram, NC in Scotland County.

Securing an adequate water

supply for Pinehurst residents is one of the key objectives outlined in the Village Council's Comprehensive Long Range Plan. In fact, 87% of residents participating in a telephone survey "felt that Pinehurst needed to develop more water supply sources."

Pinehurst has experienced numerous water restrictions because of a lack of water availability, which has had a negative impact on the quality of life for Pinehurst residents and the local economy. The Carolina Hotel has had to serve guests on disposable paper products, the hospital has had to drill private wells to ensure a stable water supply, and residents have been restricted from using water outdoors.

The 2008 McGill Water Source Evaluation and Plan proposed the WestPoint facilities as a potentially viable means of providing additional water to Moore County. Because the facilities are in the same river basin as Southern Moore County, the reuse of water within the same basin does not require a costly and time consuming inter-basin transfer (IBT) permit, as would be required to transfer water from other parts of Moore County.

Today, the water treatment plant is producing processed water and treating wastewater for a local industrial customer. Gullistan Carpets. Water quality testing indicates the facilities are capable of producing potable water for residential consumption.

The facilities are capable of producing and

treating 7 million gallons of water per day.

Based on a preliminary engineering study, upgrades to realize the full rated capacity of each plant and modernize the facilities could be

approximately \$15 to \$20 million per plant.

The Village intends to partner with other jurisdictions in the region who would like to secure a long-term water/wastewater solution for their communities. To that end, the Village intends to facilitate the formation of an

entity that will oversee the provision of water and wastewater services to the region.

Jurisdictions that could partner with the Village include Aberdeen, Laurinburg, Maxton, Moore County, Pinebluff, Raeford, Red Springs, Scotland County, and Southern Pines. The partners in the regional consortium would share in the cost of any plant upgrades and the installation of transmission lines.

Upon approval of the sale by the Scotland County Commissioners, the Village will secure financing to purchase the WestPoint assets and will also be actively working towards forming a regional consortium in the next several months.
