Fire Hydrant Information

Flowing fire hydrants within the Village is the something fire department tries to do on an annual basis. Due to increased demands on the water

system during the summer months,

Moore County Public Utilities has requested

that we delay flowing until October 1st and complete all testing by the end of February. This delay presents no danger to Pinehurst citizens.

Prior to our flowing hydrants, signs will be placed in the area to be flowed to give residents notice that the water may be somewhat discolored. The hydrants tested will be left flowing partly to facilitate the clearing of the water. Any hydrant that you observe flowing more than 24 hours should be reported to Moore County Public Utilities (910-947-6315).

- While conducting the flow test crews will also be cleaning vegetation from around the hydrants so that the visibility of the hydrant is increased. They will also be removing any obstacles that would interfere with the operation of the hvdrant.
- The fire department asks that you be mindful when planting anything that would obscure or interfere with the operations of the fire hydrant.
- The tops and caps of the fire hydrants are painted different colors. The colors represent the amount of water available from the hydrant that was determined during the last flow test
- There should be a blue reflector located in the roadway in front of each hydrant that assists the fire department in locating a hydrant during an emergency. During testing, the crews will be replacing any missing reflectors.

Builders' Workshops

Topics of discussion included building, zoning, community appearance and charges applied to

Pinehurst Greenway Phase IV

The Pinehurst Greenway System will see additional trails added in the coming months as design and construction drawings are currently underway for Phase IV. This phase will continue the route along Linden Road that will eventually tie into a utility easement behind Pine Vista Rd. leading toward Lake Pinehurst. The new section of trail is estimated to add an additional ³/₄ of a mile to the more than 3.5 miles of greenway trails already in place. Residents along Linden Road where the trail will be installed in the Village and/or State right of ways will be notified by mail


regarding the exact location of the trail as it pertains to their property. Every effort will be made to minimize disruption to existing plantings, irrigation, etc., however some of these may need to be removed where they encroach into the right-of-way. It will be the responsibility of the home owner to do so prior to construction.

As a reminder, the greenway trails are only accessible to pedestrians and bicycles, therefore no motorized vehicles, including golf carts, are allowed to utilize the trails. Local Historic District Update

Village Council has held two Public Hearings thus far on the Local Historic District Overlay. These Public Hearings were held to receive public input on the boundary of the proposed Local Historic District. The last Public Hearing will be held on September 26, 2006 at 1 p.m. Property owners are encouraged to attend the hearing if they have any concerns. It is important to understand that the geographic area located in the Old Village Center Overlay Zoning District, commonly known as "Old Town" will not be dissolved with the new Local Historic District Overlay. The properties located in "Old Town" and not in the Local Historic District boundary will only be reviewed by staff and the Community Appearance Commission.

In their regular meetings, Council has discussed the proposed Standards and Guidelines for the Local Historic District. This document will be used as a guide for development in the area. Before planning any exterior change to a home in the Local Historic District, please phone the Village Planner at 910-295-2581.

The Standards and Guidelines document, as well as the Circa Local Historic District Report and the proposed Local Historic District Overlay boundary can be viewed on the Village website at <u>www.villageofpinehurst.org</u> on the Planning and Inspections page. A brochure was mailed last month to the property owners within the proposed district with answers to some Frequently Asked Questions, as well as a chart of common work and the appropriate method of obtaining permission. Motorcycle Patrol Begins Work

In April, the Police Department acquired a 2006 Harley Davidson Electra Glide motorcycle to be used exclusively for traffic enforcement and public events. The motorcycle was part of the 2005-2006 budget and purchased from Sandhills Harley Davidson. The "Motor Unit" as it is referred to, is equipped with everything the "Motor Officer" needs to investigate traffic collisions and to enforce the traffic laws in the Village. The motorcycle has a state of the art radar unit which works while the Motor Unit is moving or if it is stationary. It also has dual mounted radar antennas for the front and rear of the motorcycle. It is capable of tracking vehicles coming at it and going away from it in either direction. The Motor Officer also has the latest "push to talk" radio so he can communicate with the department's dispatchers.

The Village of Pinehurst has experienced an increase in the volume of vehicles traveling through the Village. As a result of this increase the number of problems associated with the high volume of traffic has increased. The most recent NC Department of Transportations study conducted in 2004 revealed that the traffic circle has over 87,000 vehicles going around it a day. From January 2004 through June 2006 the Police Department issued 3,863 state citations for traffic violations within the Village limits. During that same time frame the Police Department investigated 952 vehicle collisions with one being a fatality.

Chief Ronnie L. Davis realized that the ever increasing traffic problems called for a different approach to help combat the problems. The police motorcycle is one approach to help with the traffic problems. The police motorcycle has been in use in one form or another for over 100 years. The motorcycle is capable of getting to accident scenes quicker, maneuvers through traffic easier, it is able to get into places a patrol car can not and is capable of turning around in the roadway safer and faster. The Motor Unit is going to be used everywhere in the Village but is going to concentrate in those areas where speeders are a problem and where drivers are failing to stop for red lights and stop signs.

Officer Jason Council is the first Motor Officer for the Pinehurst Police Department. Officer Council has been out and about in the Village trying to get a feel for the new Motor Unit. The Motor Unit has already been used in two public events. In May, it escorted runners from various law enforcement agencies in Moore County for the annual Special Olympics Torch Run. In July, it was the lead motorcycle in the Police Department's 1st annual motorcycle ride for Special Olympics. Officer Council is scheduled to complete a one week ride-a-long training program with the Favetteville Police Department's Motor Unit in August. He has been selected to attend the NC State

Highway Patrol Basic Motorcycle Operators course at the end of October. After completion of the two courses Officer Council will be hitting the streets on a full time basis to help make the Village of Pinehurst roadways



Pinehurst Greenway Wildlife Habitat Committee

People of all ages enjoy walking, jogging, their property near the Health or biking along the trail that runs through the Pinehurst area. The corridor of green space includes woods and open meadows. Observant hikers notice seasonal wildflowers peeking out in unexpected places. These small bursts of color, the songs of a variety of birds, the skittering of little animals and the serenity of stately pines engulf trail visitors with the beauty this of nature in our area.

The Greenway Wildlife Habitat Committee (GWH) is responsible for the Pinehurst Conservation Commission's (PCC) efforts to protect habitats for wildlife in public areas starting with the Pinehurst Greenway.

Committee Objectives and Projects

Surveys: With assistance of a consultant and volunteers, the GWH Committee surveys plant and animal habitats along the trail. The purpose is to preserve these habitats for their intrinsic value in the natural environment and for the roosting and feeding of birds and other animals. This includes an extensive bird survey along the trail. The GWH Committee maintains inventory lists and posts findings on the Village Website as the identification process continues throughout the seasons. Watch for future plantings of native species along the trail.

Trail Markers: Markers are now in place along the Greenway Trail to identify native plants. Committee members who are also Master Gardeners Volunteers provide valued expertise to this process. Surveys will continue through each season, and the Committee will add new markers as appropriate. The Committee also will solve problems created by damaged plants and non-native, invasive plants.

Bluebird Trail and Butterfly Garden: Rassie Wicker Park contains an existing bluebird trail. Committee members and others monitor this trail and will replace damaged or missing bird houses. The Committee is collaborating with First Health to locate a butterfly garden on

and Fitness Center. A consultant hired by the GWH Committee provided data and suggestions for the proposal. There is much work ahead before project becomes a reality

Public Walks:

Our trail coordinator plans public walks along the Greenway which emphasize wildlife flora and fauna along the trail She offers guided walks with a consultant or encourages non-guided use of the trail. Look for announcements for an upcoming trail walk in the fall. We are planning regularly scheduled fitness walks along the Greenway Trail. 

It all started with wedding bells and a horse race! In October 1810 Crown Prince Ludwig of Bavaria married Princess Theresa. The official festivities lasted five days and included parades, music, eating and drinking. The festivities ended with a horse race held on the green. In 1811 an agricultural festival was added to the horse race. In 1818 swings and a big tent were added. Beginning in 1896, the first of the huge beer tents became a joint venture of the large Munich proprietors. Until today, only vendors from Munich are allowed to sell beer at Oktoberfest. The Oktoberfest is the biggest fair of the world and is known worldwide. Somewhere along the way, the horse races. the agricultural shows and the like have disappeared, but the eating, drinking and dancing to the wonderful German music still continues!!

Why does Oktoberfest start in September? Due to the cool weather in Germany, the organizers decided it would be better to start it on the third week of September, ending in October.

Beth Kocher's Career with ClubCorp Brought Many Benefits to The Village of Pinehurst

would naturally think of the Carolina Hotel and the Pinehurst Country Club if you mention the name Beth Kocher. Fewer people are aware of the civic contributions Beth made during her twenty-two year career Resort, the 1994 US Senior Open also held here with ClubCorp.

the Hotel and Resort when ClubCorp purchased them in the early 1980's. Beth's civic contributions were not as numerous during the 1980's and the early 1990's, as ClubCorp's focus had to be on restoring the property to its previous grandeur. However, as planning intensified from the mid-1990's onward for the 1999 US Open. Beth's interaction with the elected and appointed representatives of Pinehurst became much more frequent. and the resultant major events hosted, and significant facilities established from the

mid-1990's until now have left an indelible positive impression on our community.

Much of Beth's work with the Village and its representatives was in the nature of planning for and implementing major facility construction that has brought lasting benefit to our community. During the last fifteen vears, major construction projects such as the new Tennis Clubhouse, the Convention Center at the Carolina Hotel, Golf Course #8 (The Centennial Course), the Spa, the Golf Learning Center, and a new swimming complex at the Carolina Hotel, were all added to the Resort's offering of amenities.

Also during this period, the Resort and the Village hosted many high profile athletic events, which brought positive attention to Pinehurst and have brought other, residual

During the latter stages of her career with ClubCorp, Beth contributed much to the community by way of her service on boards of several major area organizations, and on a number of committees undertaking major Village initiatives. Beth served on the Board of the Sandhills Area Chamber of Commerce,

Moore County Partners in Progress, and the Board of Directors for FirstHealth of the Carolinas. Beth also served on the Steering Committee which guided the development of the first-ever Comprehensive Plan for the Village of Pinehurst, which was adopted by the Village Council in 2003, the Steering Committee for the New Core Conceptual Small Area Plan, and Beth was one of the initial members of the Pinehurst Historic Preservation Commission.

Though Beth's time and attention will now be deservedly focused on her husband Brad and her grand-daughter, Madeleine Rae, her friends at the Village of Pinehurst will fondly remember her contributions to the greater community and the benefits that resulted. Best wishes to Beth in her retirement!
