## V. Public Hearing Items:

COA-17-021 A request for front porch addition, rear addition, deck, walkway and fencing at 145 Dundee Rd., Pinehurst, NC. This property can be identified as Moore County LRK# 00021108. The applicant is Brian Kennedy and the property owners are Robert & Cynthia Kennedy.

Alex Cameron, Planner read the staff report and confirmed that adjacent property owners were notified and that the property had been properly posted.

Chairman Lewis stated his concerns about the boxed chimney and his concern with it not being congruous. The applicant stated that he would wrap in it in brick if requested to do so.
