#### **MINUTES**

#### MAYOR NANCY ROY FIORILLO CALLED THE MEETING TO ORDER.

The Village Attorney informed the Council that Taser, International had been dismissed from the Armstrong litigation. This removes a major part of the plaintiff's case.

The Village Attorney briefed the Council on the results of his and the Village Manager's conference call with Reed Colfax, attorney for Align Development. Council agreed that the best course of action was to settle the matter and instructed the Village Attorney to continue these discussions.

The Village Attorney asked the Council if they had any questions or concerns regarding the opinion and position set forth by John May, attorney for Pinehurst, LLC, with regard to the ownership of Village Green Road and Palmetto Road as set forth in his letter to Mr. Newman dated November 25, 2013 (Copy attached). The Council replied that they did not have any issue with the opinion and position of Mr. May. Mr. Newman informed the Council that he would write back to Mr. May concerning same.

Upon the conclusion of the Closed Session, Councilmember Cashion moved to adjourn the Closed Session and reenter the Work Session. The motion was seconded by Councilmember Phillips and carried unanimously.
