- 2) Gross Dollar Sales include sales made beyond pre-orders. (3 additional sales in 2014)
- 3) Breakdown of expenses for 2012 are not available.
- 4) In the 2013 report from Finance, the cost of wreath samples was not included as a separate expense. So to keep the comparisons the same, I did not include this cost in 2014 expenses.
- 5) Order forms cost us \$178 in 2013 and \$382 in 2014.
- 6) In 2014 we had more sales, but we made less money in gross sales dollars.
- 7) In 2014 we had 56% greater sales in the less expensive 12" wreaths and 66% lower sales of more expensive Fraser firs. This equals approximately \$650 reduction in gross sales dollars.
- 8) We did not sell bows in 2014.
- 9) Wholesale expenses for wreaths to the maker were slightly higher in 2014, but these expenses were not a major factor in our profit changes.
