Public Meeting:

1. The purpose of this Public Hearing is to consider an appeal of the Historic Preservation Commission's denial of a Certificate of Appropriateness at a special meeting on January 30, 2014 for a new home at 170 Everette Road, Pinehurst, NC. More specifically, the denial was for property identified as Moore County LRK #'s19490 and 23548 and being owned by Putterboy 7, LLC. As outlined in Section 12.3.9 b) of the Pinehurst Development Ordinance this appeal shall be in the nature of certiorari. The appellant is Putterboy 7, LLC.
