General Discussion

Molly Goodman, Senior Planner reminded the Commission that training with Robin Currin, Village Attorney will be held on February 8, 2011 at 10:00 am in the Fire Department training room.

Molly Goodman, Senior Planner also discussed with the Commission the Village Center Roundtable shared site online, which will enable the Commission members to review the various committees and their projects. Joyce Franke brought up the changing of road names along NC 2 in the Village. They all agreed that this was outside of the Historic Preservation Commission's scope.
