Jack Farrell made a motion to approve the February 11, 2015 Minutes; Judy Davis seconded the motion, which was unanimously approved.

III. Approval of Normal Maintenance and Minor Work items

IV. The following were sworn in:

Chad Hall, Senior Planner; Craig Schiffmacher, CDS Construction; and Russ Cribbs, Cribbs Construction.

V. Public Hearings: Chairman Jim Lewis opened the Public Hearing.

COA 15-010: Request for accessory building (greenhouse) in rear yard. This property is located at 5 Carolina Vista and can be identified as Moore County Parcel ID# 23540.

Chad Hall, Senior Planner read the staff report and confirmed that adjacent property owners were notified and that the property had been properly posted

Craig Schiffmacher, CDS Construction was present to answer any questions or address any concerns.

Jim McChesney made a motion to close the Public Hearing; Amanda Jacoby seconded the motion, which was unanimously approved.

After discussion, Jack Farrell made a motion to issue a Certificate of Appropriateness for the construction of a greenhouse as submitted and to adopt the Findings of Fact; Amanda Jacoby seconded the motion, which was unanimously approved.

The vote was (4-0) issue a Certificate of Appropriateness construction of the greenhouse as submitted.

Chairman Jim Lewis opened the Public Hearing.

COA 15-009: Request for new home construction. This property is located at 35 Craig Road and can be identified as Moore County Parcel ID# 20110357.

Chad Hall, Senior Planner read the staff report and confirmed that adjacent property owners were notified and that the property had been properly posted

Russ Cribbs, Cribbs Construction was present to answer any questions or address any concerns of the Commission. Russ Cribbs asked the Commission about vertical siding and the Commission responded that they will review the Standards and Guidelines.

Jim McChesney made a motion to close the Public Hearing; Judy Davis seconded the motion, which was unanimously approved.

After discussion, Jim McChesney made a motion to issues a Certificate of Appropriateness with the following conditions: 1)Standard shutters are to be installed; 2) Horizontal lap sidings on first level; 3) No chimney; and 4) No metal roof and to adopt the Findings of Fact; Judy Davis seconded the motion, which was unanimously approved.

The vote was (4-0) to issue a Certificate of Appropriateness with the conditions as stated above.

The Commission requested that for future submittals from Russ Cribbs that he attach a written list of any changes to plans brought to the Commission for their review. Russ Cribbs agreed to the request.
