I. Call to Order by Mayor Nancy Fiorillo

Mayor Nancy Fiorillo called the meeting to order for the Neighborhood Advisory Committee.

II. Review notes from September 24, 2018.

The committee approved the notes.

III. State of the Village Report- Lauren Craig, Performance Management Director.

Lauren Craig, presented the committee members where to find the State of the Village report and the Resident and Community Surveys on the Village Website.

John Bouldry stated last year's survey we had 9 pages of comments and this year we had 54 pages of comments. Debbie Lalor asked if staff could tell what neighborhood the completed surveys came from. Lauren explained we could tell and there was a map, on the Village website, which displayed surveys return by neighborhood.

Lee Turner asked if there was a communication breakdown between Businesses and the Village of Pinehurst. He attended an event and there was no advertising, he thought it would be nice if the Village would show private business events on the Village website. Mayor Nancy Fiorillo explained various websites that posted most of the private functions in the Village and also stated that Councilmember Drum and Davis were the liaisons for the businesses in Pinehurst and would look into the promotion of events a little further.

Councilmember Bouldry stated the Village was awarded the Digital City award for FY18 and that our investment in IT was well worth it. Also, with the large threat of malware, the IT staff really does a great job protecting Village network.

Lauren noted the annual State of the Village meetings are coming up on October 30th and November 1st.

IV. Other Business - Neighborhood Reports

Charles Collini asked about the position of the Council for the quarter recent sales tax. Mayor Nancy Fiorillo stated the Council supports the proposed ¼ cent sales tax for the school needs and signed a resolution to show their support at the last Council meeting.

Tony Elms asked about the satisfaction rate, from the State of the Village report, on traffic laws and what was going to be done to improve this number. Lauren stated a Birdie team was put together last year and evaluated the issues and recommended 2 new traffic officers be hired, and those 2 officers have already been added to the Police force to help enforce traffic laws.

- Debbie Lalor of Downtown: Asked about the parking for the Brewery and hoped that Council would take that into consideration when deciding on the Pinehurst Medical facility.
- Monica Converse of Lake Pinehurst: Asked about debris clean up and if the Village had completed their pickups.
- Charles Collini of Old Town West: Nothing to report.
- Lee Turner of Clarendon Gardens: Explained Clarendon Gardens was designed without sidewalks or streetlights and he likes it like that, he wants to make sure he is informed before sidewalks are installed. He inquired about what the process was if a street or community wanted sidewalks. Jeff Sanborn, Village Manager, explained the process the Village has used in the past to add sidewalks, which includes input and a desire from the entire community. Mr. Sanborn also stated that sidewalks in that area were not under discussion. Mr. Turner also asked if there were designated hours for trick-or-treating, and staff informed him there are no set hours. He requested the Village look into establishing trick-or-treating times possibly from 6pm to 8pm. Last year he had some issues with trick-or-treaters coming to his door when he had turned his porch light off.
- Beverly Braunschiedel of Midland CC: Nothing to report.
- Jan Kane of CCNC: Had a security meeting at CCNC earlier in the day. Speeding inside of CCNC is becoming a problem again. They are currently looking at different options to help control speeding. Also, they are looking into the parking issues around the golf area.
- Beverly Reynolds of The Woodlands: Stated they are having issues with residents walking their dogs and not cleaning up after them. They are also having issues with renters in the neighborhood and she has seen an increase in speeding on Salem Drive.
- Lydia Boesch of Pinewild: Stated that Pinewild residents are standing behind the Village to support the proposed ETJ. They are really concerned with the appearance along 211. She inquired about adding a dog park at the West Pinehurst Park.
- Cathy Harpster of Taylorhurst: Nothing to report.
- Al Mangum of Oakmont Circle: Thanked the Village Public Service staff for doing a great job.
- Tom Campbell of Montocillo: Wanted to know more detail about the streets that others are reporting in such bad shape. Most of the road problems seem to be the cuts in the road.
