Chairman Warren closed the Public Hearing.

## **General Discussion**

The Commission voted unanimously to recommend the amendments to the Local Historic District Standards and Guidelines to go before Village Council for approval. (The amendments are on file)

Commission members brought up concern over residential mailboxes that are going up in the Village with no standards for their design or placement. Staff reminded the Commission that they currently do not have authority of items in the right-of-way. Chairman Warren will write a memo to Village Council of their concerns.

The Pinehurst Civic Group is co-sponsoring the Pinehurst Expo and has invited the Historic Preservation Commission to participate. The Pinehurst Expo will be September 21, 2011 from 3:00 pm to 8:00 pm at the Fairbarn. The Commission members discussed attending and worked out their times to man their booth.
